The proposed action was contemplated in pursuance of intimation received u/s 74 of the CGST Act due to the alleged excess refund of Input Tax Credit and non-payment of Integrated Goods and Services Tax.</p> <p>Pursuant to the hearing on 07 March 2024, the Hon'ble High Court held that no action under Section 83 of the CGST/ KGST Act shall be resorted to till next date of hearing scheduled on 10 April 2024.</p>
