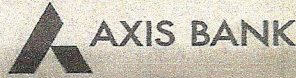

ICEA: DGFT Order Checks Illegal Import of Electronic Items

New Delhi: The electronics manufacturing industry has said the recent government notification to explicitly ban the import of 49 second-hand goods such as mobile phones, printers and laptops without authorisation, has plugged a gap in norms which would check unauthorised inward shipments. "This effectively blocks the possibility and the practice of unethical imports which were being resorted to," Indian Cellular and Electronics Association (ICEA) chairman Pankaj Mohindroo told ET.

He said that since the CRO did not cover second-hand goods earlier, there were imports without BIS registration under the guise that these are second-hand goods.

"This has been blocked now. The same goods were also getting imported by declaring a very small value and paying correspondingly a small penalty, which therefore did not necessitate a DGFT authorisation."
