Govt ready for insurance PSU privatisation

PRESS NOTE OF INDIA New Delhi, July 4

TO FACILITATE PRIVATISATION of a public sector insurance firm, the government is working on amendments to the General Insurance Business (Nation-

alisation) Act (GIBNA), and a Bill for that is likely to come up in the upcoming monsoon session. The monsoon session is expected to begin from July 19. The Act, which came into force in 1972, provided for the acquisition and transfer

of shares of Indian insurance companies and undertakings of other existing insurers in order to serve better the needs of the economy by securing the development of general insurance business. The amendments to the GIBNA are being worked out

and may be tabled in the upcoming session to help privatisation of a general insurance company announced in the Budget this year, sources said. Finance minister Nirmala Sitharaman, in Budget 2021-22, had announced a big-

ticket privatisation agenda, including privatisation of two public sector banks and one general insurance company. The government has budgeted 41.75 lakh crore from stake sale in public sector companies and financial institutions during 2021-22
