Kharge wants to chalk out a strategy for the upcoming assembly elections. He said the idea of this meeting is to chalk out an initial strategy to reach the grassroots.

Pilot warned of starting an agitation in a big way if their demands are not met by the end of May. In Chhattisgarh, Chief Minister Bhupesh Baghel and state minister TS Singhdey are fighting for the top post. In Telengana, Congress state unit chief Revanth Reddy is confronted by state leaders who consider him an outsider.
