In compliance with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 read with the MCA Circulars and the Listing Regulations, the details pertaining to dispatch of Postal Ballot notice and details of the Special Business item set out, through Postal Ballot by remote electronic voting ('evoting') process were published in "Business Standard", English Newspaper and in "Sakal", Marathi Newspaper on November 15, 2022.

The voting period for remote e-voting commenced on Tuesday, November 15, 2022 at 09:00 a.m. (IST) and concluded on Wednesday, December 14, 2022 at 05:00 p.m. (IST) both days inclusive. The votes cast by Remote e-voting through KFin Technologies Limited received only upto December 14, 2022 05:00 p.m. (IST) were considered valid for scrutiny and the platform was blocked thereafter.
