क्रिकेट की अवैध सट्टेबाजी ऐप में किसी संलिप्तता या भूमिका को बर्नन पॉ

देव चटर्जी मुंबई, 14 नवंबर

डाबर समूह के बर्नन परिवार ने अवैध क्रिकेट सट्टेबाजी ऐप में किसी तरह की संलिप्तता या भूमिका से इनकार किया है। पिछले हफ्ते मुंबई पुलिस के पास दर्ज शिकायत में इस तरह का आरोप लगाया था। बर्नन परिवार ने कहा कि पुलिस शिकायत के पीछे निहित स्वार्थ है जो वित्तीय सेवा कंपनी रेलिंगेयर एंटरप्राइजेज के अधिग्रहण की राह में बाधा खड़ी करना चाहते हैं।

बर्नन परिवार के प्रवक्ता ने कहा, 'हमें ऐसी प्राथमिकी (एफआईआर) को लेकर कोई औपचारिक संदेश नहीं मिला है। हालांकि हमने एफआईआर की प्रति देखी है जिसे मीडिया में प्रसारित किया जा रहा है। एफआईआर पूरी तरह झूठी और बेबुनियाद है।' 7 नवंबर को दर्ज प्राथमिकी के अनुसार मुंबई पुलिस ने धोखाधड़ी और जुए से संबंधित विभिन्न धाराओं के अंतर्गत महादेव ऐप के प्रवर्तक सहित 32 लोगों के खिलाफ शिकायत दर्ज की है। प्राथमिकी में पुलिस ने डाबर समूह के चेयरमैन मोहित बर्नन, निदेशक गौरव बर्नन तथा अन्य को भी नामजद किया है। बर्नन परिवार के प्रवक्ता ने कहा कि मीडिया में प्रसारित प्राथमिकी की प्रति उन्होंने देखी है जिसमें आरोप लगाया जा रहा है कि मोहित और गौरव बर्नन सोधे तौर पर कुछ आरोपियों से जुड़े हुए हैं। उन्होंने कहा कि इसमें 'एफ' का उल्लेख किया गया है जो कुछ तथाकथित संबंध



को दर्शाता प्रतीत होता है।

प्रवक्ता ने कहा, 'मोहित और गौरव बर्नन मीडिया में चुनिंदा तौर पर प्रसारित की जा रही प्राथमिकी में शामिल आरोपियों को जानते तक नहीं हैं और न ही उनसे कभी मिले हैं।'

बयान में कहा गया है, 'प्राथमिकी ऐसे समय में की गई है जब बर्नन परिवार ने रेलिंगेयर एंटरप्राइजेज में अपनी मौजूदा 21.24 फीसदी हिस्सेदारी बढ़ाने की मांग की है और सभी की अधिग्रहण सहिता के तहत वैध खुली पेशकश किया है। इसके तहत बर्नन परिवार बोर्ड तथा निगमकों के समक्ष रेलिंगेयर की वर्तमान चेयरपर्सन रॉसि सलूजा द्वारा किए जा रहे कुछ प्रशासनिक मुद्दों को नोटिस में लाया है।' बयान में कहा गया है, 'बर्नन

परिवार इस तरह की अवैध हरकत से हैरान है। हालांकि इस बात पर दृढ़ हैं कि हम योजना के मुताबिक रेलिंगेयर एंटरप्राइजेज के अधिग्रहण की दिशा में आगे बढ़ेंगे।'

बता दें कि बर्नन और रॉसि सलूजा की अगुआई वाले रेलिंगेयर एंटरप्राइजेज के

बोर्ड के बीच जबानी जंग चल रही है और दोनों खेमे एक-दूसरे के खिलाफ नियामकों से शिकायत कर रहे हैं।

बर्नन परिवार ने रेलिंगेयर के लिए खुली पेशकश की है जिस पर 2,200 करोड़ रुपये का अतिरिक्त खर्च होगा। बर्नन परिवार के पास पहले से ही रेलिंगेयर में 21 फीसदी हिस्सेदारी है और उन्होंने पिछले महीने अतिरिक्त शेयर खरीदने के लिए खुली पेशकश की थी। खुली पेशकश के बाद रेलिंगेयर

अदाणी के सलाहकार पर शुरू हुआ विवाद

भाषा नई दिल्ली, 14 नवंबर

पर्यावरण मंत्रालय को एक समिति में अदाणी ग्रीन एनर्जी लिमिटेड (एनजीएल) के एक सलाहकार को शामिल किए जाने के मुद्दे पर मंगलवार को राजनीतिक विवाद शुरू हो गया और विपक्षी दलों ने इसके लिए सरकार पर निशाना साधा।

केंद्रीय पर्यावरण मंत्रालय ने सितंबर में जलविद्युत और नदी घाटी परियोजनाओं के लिए अपनी विशेषज्ञ मूल्यांकन समिति (ईएसी) का पुनर्गठन किया था और चौधरी को अपने सात गैर-संस्थागत सदस्यों में नामित किया था। पुनर्गठित ईएसी की 17-18 अक्टूबर को हुई पहली बैठक का ब्योरा पर्यावरण मंत्रालय के

'परिवेश' पोर्टल पर उपलब्ध है जिसके अनुसार महाराष्ट्र के सातारा में एनजीएल की 1500 मेगावाट क्षमता वाली तरली पंपिंग स्टोरेज परियोजना पर बैठक में विचार-विमर्श किया गया था।

चौधरी ने स्पष्ट किया कि उन्होंने 17 अक्टूबर की बैठक में भाग लिया था, लेकिन एनजीएल की तरली परियोजना पर विचार वाले सत्र में वह शामिल नहीं हुए थे। उन्होंने कहा कि वह एनजीएल के सलाहकार के रूप में काम करते हैं और कंपनी के वैतनिक कर्मचारी नहीं हैं। वह एनएचपीसी में 36 वर्ष तक सेवाएं दे चुके हैं और मार्च 2020 में निदेशक (तकनीकी) के रूप में सेवानिवृत्त हुए थे। उन्होंने अप्रैल 2022 में एनजीएल के सलाहकार के रूप में काम करना शुरू किया था।
