We wish to bring to your kind attention certain facts with reference to the continued Lockdown since 19th March, 2020 till now:

- 1. On the evening of 18th March, 2020 suddenly our office and production departments were shut down pursuant to the emergency orders from the Government in this regard.
- 2. Our registered office and factory operations have been completely stopped till now.
- 3. We are situated at A-5, Wagle Industrial Estate Thane, 400604. This area is considered as Hot Spot due to the prevalence of many patients suffering from Corona virus.
- 4. Our 9 months results ended on December, 2019 were announced on 12th February, 2020 with statutory auditors report thereon.
- 5. Unfortunately due to sudden demise of a senior person in Accounts Department Late Mr. Avinash Bhatkar in the month of February, 2020 situation has worsened further. A new staff member was appointed on 18th March 2020 however immediately thereafter this lockdown was started. Lot of Data entry is pending to be completed in ERP for Quarter IV.
- 6. On restarting the operations process of yearend Stock Taking and their valuation has to be undertaken and thereafter same needs to be posted in ERP.
- 7. Physical verification of assets, cash balances, yearend balance certificates from banks and Bank reconciliations thereof need to be undertaken.
- 8. Audit of entire last quarter January 2020 to March 2020 and Secretarial Audit along with yearend matters is pending on this date.
