
The Board places on record its sincere appreciation for the remarkable contribution made by Mr. Marzin R. Shroff during his tenure with the Company.

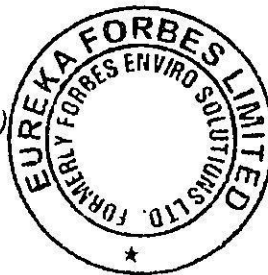
