### Re: Scrutinizer's Report on postal ballot voting including voting by electronic means in respect of passing of the resolutions contained in the Notice dated June 13, 2022 through postal ballot.

Dear Sir,

I, Mr. Swapneel Patel, Practicing Company Secretary, Partner of M/s. Shah Patel & Associates, having its office at 198/A, Jaya Niwas CHS, Jain Society, Sion West, Mumbai - 400 022, being appointed as scrutinizer by the Board of Directors of Relicab Cable Manufacturing Limited ("The Company") in their meeting dated June 10, 2022 for the purpose of scrutinizing the E-voting process under the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (Rules) in respect of passing of the resolutions contained in the postal ballot notice dated June 13, 2022 ("Postal Ballot Notice").

The Management of the Company is responsible to ensure the compliance with the requirements of (i) the Companies Act, 2013 and rules thereunder and (ii) the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to postal ballot voting including e-voting for the resolutions as stated in the Postal Ballot Notice.

My responsibility as a scrutinizer is restricted to ensure that the voting process by E- voting and voting by Postal Ballot forms are conducted in a fair and transparent manner and presenting a Scrutinizer's report of the total votes cast "in favour" or "Against" the resolutions in the Postal Ballot Notice. My report is based on the reports generated from the e-voting system provided by National Depository Services Limited (NSDL), an agency appointed by the Company to provide e-voting facilities and the postal ballot received through post till the time fixed for closing of the voting process i.e. till 5 p.m. on July 14, 2022.

I submit my Scrutinizer's Report on the results of voting through e- voting as under:

- As per General Circular No. 14/ 2020 dated April 8 , 2020 and the General Circular No. 17/ 2020 dated April 13, 2020, in relation to "Clarification on passing of ordinary and special resolutions by companies under the Companies Act, 2013 and the rules made thereunder on account of the threat posed by COVID - 19" issued by the Ministry of Corporate Affairs, Government of India (the "MCA Circulars") and due to difficulty in dispatch of Postal Ballot notice, Postal Ballot form / self-addressed envelope etc. , by post or courier, on account of threat posed by COVID-19 pandemic situation, the Company has sent the Postal Ballot Notice dated June 13, 2022 on Monday, 13<sup>th</sup> June 2022 by email only to the members whose email ids were available with the Company / RTA.
- The notice of postal ballot was sent to the members whose name(s) appeared on the Register of Members / list of Beneficial Owners as received from National Securities Depository Limited (NSDL) / Central Depository Services (India) Limited (CDSL) as on cut-off date i.e. Friday 03<sup>rd</sup> June 2022
- Particulars of votes cast through electronic means only have been entered in the register separately maintained for the purpose.
- Since there was no voting by physical postal ballot form, the question of keeping them under my safe custody before commencing the scrutiny does not arise.
- The votes cast through electronic means were unblocked on 15<sup>th</sup> July 2022
- Votes cast through electronic means were scrutinized and the shareholding was matched/confirmed with the Register of Members of the company /list of beneficiaries as on Friday 03<sup>rd</sup> June 2022.
