This is to inform you that the board of directors of Sanghi Industries Limited ("Company") met today (i.e., August 3, 2023) and *inter alia* approved the: (a) proposal to borrow funds up to an amount not exceeding INR 300,00,00,000 (Indian Rupees Three Hundred Crore only) by way of an unsecured inter-corporate deposit from Ambuja Cements Limited ("Lender") on terms and conditions mutually agreed between the Company and the Lender and recorded in the inter-corporate deposit agreement to be entered into by the Company and the Lender ("ICD Agreement"); and (b) execution of definitive and other ancillary/ incidental documents in relation to the inter-corporate deposit (including the ICD Agreement). Subsequent to the board approval, the Company has executed the ICD Agreement.
