### 1 killed, 4 injured as three-storeyed building collapses in UP



Aligarh : According to authorities, a three-storey building fell in Upper Kot locality in the old city region of here on Saturday, killing one person and badly injuring four others. Rescue operations began immediately, according to District Magistrate Indevir Singh, and the injured are being treated at Jawaharlal Nehru Medical College Hospital and Malkhan Singh Hospital. He stated that rescue activities are still ongoing. The structure was used as a manufacturing godown. Officials stated that because the event occurred late night, just a few people were present in the building. According to residents, the structure was in bad condition, and last week's rain and flooding exacerbated the issue.

### Gold smuggled worth Rs 1 crore seized at Nagpur Airport



Nagpur : A traveller from Sharjah was arrested on Friday early morning at Dr Babasaheb Ambedkar International Airport at Nagpur for carrying 2 kgs of gold, valued at about Rs 1

crore. Gautam Setia is stated to be the name of the person travelling through Air Arabia Airlines, the flight of which arrived at Nagpur at 4.32 am. He carried

with him ten gold biscuits of 10 gms each and two bangles. The Customs officials took Sethia in possession and seized the gold carried by him. The instances of gold smuggling via Sharjah have increased in the recent past. During the last seven years gold worth over Rs 4.96 crores have been seized. Besides the gold, arms, liquor, drones, and cigarettes in large quantity were also seized. Special attention is being paid at the Nagpur Airport, particularly on the flights coming from Sharjah. Nagpur is also considered to be a transition place for narcotics.

### Maharashtra Governor seeks society's contribution in making Divyang self reliant

Mumbai : Stating that service to the Divyang persons is service to God, Maharashtra Governor Bhagat Singh Koshiyari sought the contribution of philanthropists and donors in society in making Divyang persons 'Aatma Nirbhar'. The Governor was speaking after inaugurating the 15th Diwali Sneh Sammelan for Divyang persons at Malad in Mumbai on Saturday (15th Oct). The programme was organised by the Hetu Charitable

Trust in association with 'Saksham' and Maharashtra State Human Rights Commission. The Governor said even though the State and Central governments are doing their best to help the Divyang persons, the society must come forward to help them in becoming self-reliant. In this connection he said, given an opportunity, he would like to dedicate himself in the service of Divyang persons. The Governor announced a donation



of Rs.5 lakh to Hetu Charitable Trust and another Rs.50,000 to the Musical group of Divyang persons. The Governor presented sweets and notebooks to Divyang children and their parents on the occasion. Donors were also felicitated at the hands of the Governor. Chairman of Maharashtra State Human Rights Commission (MSHRC) Justice (retd) K K Tated, Member of MSHRC A Sayeed, President of JIO Ghewarchand Bohra, philanthropist Dharmesh Mandaliya and Founder of Hetu Charitable Trust Rikhabchand Jain were present. Divyang musicians performed a musical orchestra on the occasion.

### Income tax raids on builder's premises



Indore : The Income Tax Department and Enforcement Directorate have raided the premises

of other builders including builder Tinu Sanghvi. Presently the process is going on and the documents are being scrutinised. The Income Tax Department and the ED team started action at the locations of the builders of the city from eight in the morning. Tinu Sanghvi has an office of Sanghvi Construction at Jawahar Marg. Apart from them, action is also being taken at other places including the offices, residences of other builders.

The raids were conducted by the department at various locations of real estate firm of Indore in the past. The Income Tax Department had seized crores of rupees in this raid conducted simultaneously at 45 locations including Delhi, Lucknow, Gurgaon, Chandigarh and the residence of the company's office and officers across the country. During this, an amount of 1.5 crore was seized from the house of a top official.

### Ram Rahim leaves for Baghat from jail under tight security

Rohtak : Dera chief Ram Rahim, serving a sentence of 20 years in the Sunari jail in the Sadhvi sexual abuse case, was released on parole in the morning and left for the Dera in Baghat, Uttar Pradesh under tight security. Ram Rahim was accompanied by his daughter Honeypreet. Tight security arrangements were made in the jail premises in view of the Ram Rahim parole. A long with this, a team of police has left for UP with Ram Rahim. Dera chief will be prohibited from

going to Sirsa Dera, conditionally allowed to stay in any other Dera. There will be security of Ram Rahim during the parole. The Dera Sacha Sauda chief had applied for parole for forty days, which was approved by the government on Friday. Ram Rahim was sentenced to 20 years in prison by a special CBI court in the Sadhvi sexual abuse case in 2016. Ram Rahim is serving his sentence in jail since then. Even before this, the Dera chief has got parole twice.
