## Sub: Update regarding the incident at Century Rayon plant, Shahad ("the plant")

This is with reference to our intimation(s) regarding incident at Century Rayon plant, Shahad, vide our letter Nos. GIL/CFD/SEC/24/184/SE and GIL/CFD/SEC/24/185/SE dated  $23^{rd}$  September 2023 and  $25^{th}$  September 2023 respectively, we hereby inform that the Department of Industrial Safety and Health ("DISH"), Kalyan has permitted the plant to restart the operations of Carbon Disulphide ("CS<sub>2</sub>") refining section of the plant, post compliance of the conditions stipulated in the said order issued by DISH.

We have also obtained requisite permission(s) from other concerned departments including Police Department and Maharashtra Pollution Control Board, Regional Office, Kalyan (MPCB) with whom we have deposited Bank Guarantee of Rs. 2 lakh as prescribed by MPCB which shall be forfeited for re-starting the operations as mentioned above. Accordingly, the operations of  $CS_2$  refining section have re-started today.
