- Since the closure of the financial year, the Company's operations have been partially disrupted by the local lock downs due to the COVID-19 severe crises. With the experience gained by the previous lock down, the Company has geared up to ensure that the lock downs do not severely impact the operations which are possible during the period of lockdown and post lock down period. Based on management's assessment, the Company does not see any adverse impact on its operations.
- The figures for the quarter ended March 31, 2021 and quarter ended March 31, 2020 are the balancing figures between the audited figures in respect of full financial year and the published year to date figures up to the third quarter of the relevant financial year.
