Gujarat HC notice over PIL challenging green clearances to DDPT projects



AHMEDABAD: The Gujarat high court on Wednesday issued notice to the authorities concerned over a PIL seeking cancellation of environmental and Coastal Regulation Zone (CRZ) clearances granted to Deendayal Port Authority for development works in port. The PIL claimed that the exercise of seeking and granting environmental clearances had taken place by suppressing the information

suppressing the information that mangroves exist in that

that mangroves exist in that area.

Petitioners Saleman Jakhariya and Bharat Patel have contended that the ministry of environment, forest and climate change and the Gujarat Coastal Zone Management Authority (GCZMA) granted environmental and CRZ clearances in 2016 to the port authority for seven integrated facilities within port area, and for three other facilities in 2020. They have claimed that the clearances were sought by suppressing information about vegetation.

Arguing for the petitioners advocate Amit

Arguing for the petitioners, advocate Amit Panchal submitted that the Panchal submitted that the central authority was not informed about the presence of mangroves in the area and submitted further that the Supreme Court has issued directions not to touch

mangroves.

The PIL stated that the area falls within CRZ-1A category under CRZ notification of 2011. But CRZ

clearance was granted under CRZ 1(B) category, CRZ-III and CRZ-IV categories. The challenge is to the clearances granted under allegedly wrong category. The petitioners claimed that the port authority has deliberately suppressed the presence of mangrove trees in the areas where the projects are to be executed. Information suppression was allegedly done to avoid restrictions, and GCZMA and

SURAT: A four-year-old boy was mauled to death by stray dogs in Kareli village near the city early on Wednesday. Boy's family members told police that the dogs might have attacked him when he went to answer nature's call. Ashirwad Machhar was attacked by at least four dogs at around 1 am and sustained severe injuries on his neck. He was declared dead while he was being

shifted to a hospital in Bardoli. During preliminary post-mortem examination it was found that the boy died due to heavy blood loss. Police have registered a case of accidental death at Palsana police station.

They were working at a construction site in the compound of Kejiwal Mill and were living in the mill's compound. The deceased was sleeping in the open with his family and other labourers when the incident took place.

Morbi bridge collapse: Oreva Group MD Jaysukh Patel sent to judicial custody

MORBI: A court in Gujarat's Morbi town on Wednesday sent Oreva Group Managing Director Jaysukh Patel, one of the accused in the Morbi bridge collapse case, to judicial custody after the end of his police remand. Patel, whose company

was responsible for the operation and maintenance of

operation and maintenance of the bridge, surrendered before the court on January 31 after it issued an arrest warrant against him. He was later arrested by the police. After being on the run for three months, millionaire businessman and Oreva Group's managing director Jaysukh Patel surrendered in a Morbi court on Tuesday and was formally arrested in connection with the suspension bridge collapse that killed 135 people on October 30.

that killed 135 people on October 30. On February 1, Patel was remanded to police custody for seven days by Morbi's Chief Judicial Magistrate M J Khan in the case of collapse of the

Judicial Magistrate M J Knan in the case of collapse of the suspension bridge here in October I ast year which claimed 135 lives.
Oreva group MD Jaysukh Patel sent to 7-day police custody in Morbi bridge collapse case A court in Gujarat's Morbi town on Wednesday sent managing director of Oreva Group Jaysukh Patel in sevenday police custody in a case related to the Morbi suspension bridge collapse which claimed 135 lives last year. Patel was produced before the magistrate on Wednesday after the completion of his police remand.

Since the Special Investigation Team (SIT)

formed by the state government to conduct a probe into the case did not seek further remand, Magistrate Khan sent Patel in judicial custody. The development comes days after a sessions court here rejected the bail applications of seven other accused persons arrested last year in the bridge collapse case.

In all, the police have so far arrested 10 persons, including Patel, in connection with the incident. Besides

Patel, the others arrested in the case are two managers of the Oreva Group entity, two ticket-booking clerks, three

security guards and two sub-contractors who were given the bridge repair work by the Oreva Group. While the Morbi
