The voting is scheduled to take place on Friday, the Vidhan Sabha secretariat said. The post fell vacant on Wednesday following the resignation of Vijay Kumar Sinha, a BJP leader, against whom members of the ruling alliance had moved a no-confidence motion.

Complaint filed in court against Muslim minister

MUZAFFARPUR (BIHAR): A complaint petition was filed in a court in Bihar's Muzaffarpur against Information Technology Minister Mohammad Israel Mansuri for visiting the Vishnupad temple in Gaya. Muzaffarpur-based social activist Chandra Kishore Parashar filed the petition seeking registration of an FIR against the minister for "hurting religious sentiment of Hindus". "My client, in his complaint, said that the minister, being a Muslim, should not have visited the Vishnupad temple as only those who follow the Sanatana Dharma are allowed to visit it. The court will hear the matter on September 2," Parashar's lawyer Ravindra Kumar Singh said here on Wednesday.

Man ends his life after being 'harassed' by cop

KANNAUJ (UP): A 54-year-old man allegedly committed suicide by hanging himself from a tree after being "harassed" by a policeman at Jalalpur Thakuran village here. Family members of the dead have alleged that he was disturbed over a police sub-inspector threatening him of sending him to jail in connection with a murder case. Tukman used to live in a house constructed in an agriculture field and on Thursday morning he was found hanging from a tree, police said on Thursday. Angry over this, locals staged a sit-in keeping the body on the eastern bypass road, disrupting vehicular traffic for around three hours.

Bhupendra Chaudhary appointed UP BJP chief

NEW DELHI: The BJP on Thursday appointed Uttar Pradesh cabinet minister Bhupendra Chaudhary as the party's chief in the state. His appointment is seen as the BJP's attempt to reach out to the influential Jat community, which was at the forefront of the year-long farmers' protest against the three contentious farm laws. With the appointment of Chaudhary, also the state Minister for Panchayati Raj, Uttar Pradesh has become the third state where the BJP will be headed by a Jat leader, after O P Dhankar in Haryana and Satish Poonia in Rajasthan.

Man gets 20 years' RI for raping minor girl

MAINPURI (UP): A court in Mainpuri district of Uttar Pradesh sentenced a man to rigorous imprisonment of 20 years for raping a four-yearold girl in May 2017. Special judge for POCSO cases Poonam Rajput also slapped a fine of Rs 50,000 on the convict, Rishi Ram Kashyap. The sentence was awarded on Wednesday. According to Superintendent of Police Kamlesh Dixit, the convict lured the girl into his house and raped her in May 2017. Hearing her cries, locals and family members of the girl rushed to the house, nabbed the culprit and handed him over to the police, Dixit said.

Maha: 38 booked in Bhiwandi for theft

THANE: Thirty-eight persons have been booked for alleged power theft in Bhiwandi in Thane district on a complaint filed by the Maharashtra State Electricity Distribution Company Limited, police said on Thursday. As per the complaint, 1.12 lakh units of electricity worth more than Rs 20 lakh were stolen over a period of one year, MSEDCL official Vijay Dudhbhate said. The complaint was filed after raids were conducted in the residential areas of Pimplas and Kongaon villages by an MSEDCL team under Assistant Engineer Abhishek Dwivedi on July 8, an official of Shanti Nagar police station said.

Actor Khushbu's remark on Bilkis Bano sparks debate

NEW DELHI: The CBI has filed a charge sheet against five persons, including a Joint Drug Controller of the Central Drugs Standard Control Organisation(CDSCO) and a Biocon Biologics executive, in a Rs nine lakh bribery case. The agency in its charge sheet filed on August 18 had alleged that the bribe payment was made to Joint Drug Controller

S Eswara Reddy after clearance from associate vice president of Biocon Biologics L Praveen Kumar, they said.

Actor Khushbu Sundar's tweet against the release of men involved in rape has set off a series of reactions and debate and her party the BJP on Thursday maintained that the release of 11 convicts by Gujarat in the Bilkis Bano case was as per law and there was absolutely no politics involved.

A leading women's outfit said it was time for persons like Khushbu to introspect, adding secular, democratic forces are the right destination to fight for women's honour and rights.

National president of BJP's women's wing Vanathi Srinivasan said that through her



tweet, Sundar has conveyed that injustice must not befall on women and there is absolutely no second opinion about that. In this specific matter of release of 11 convicts by Gujarat, the due process of law was followed took a decision following the recommendations of a committee that made a complete scrutiny of each and every case, she said.

This process was following a Supreme Court directive on a petition filed by a convict. "The (Gujarat) government followed due process of law. They were not released for political reasons," Srinivasan told PTI.

Sundar had tweeted: "A woman who is raped, assaulted, brutalised and her soul scarred for life must get justice. No man who has been involved in it should go free. If he does so, it's an insult to humankind and womanhood. #BilkisBano or any woman, tics n ideologies. Period."

Meanwhile,

leader Rahul Gandhi on Thursday demanded justice for Gujarat riots survivor Bilkis Bano and alleged that those giving hollow slogans like 'Beti Bachao' are "saving rapists". The 11 convicts were released on August 15 under the Gujarat government's remission policy after serving 15 years in jail. "Those giving hollow slogans like 'Beti Bachao' are saving rapists," Gandhi said in a tweet in Hindi. "Today, the question is about the respect and rights of the women of the country. Give justice to Bilkis Bano," the former

Congress chief said.

16-month-old boy becomes youngest organ donor

he family of a 16-month-old boy who suffered fatal injuries and was declared brain dead at the AIIMS in Delhi donated his organs, offering a fresh lease of life to two patients. According to doctors, the boy was the youngest organ donor at the All India Institute of Medical Sciences (AIIMS).

His kidneys and liver were transplanted in two other kids, while his heart valves and corneas have been banked at AIIMS, they said.

The boy. Rishant, suffered a fall and was seriously injured on August 17. His father, Upinder, a private contractor, took him to a nearby private hospital in Jamuna Park. He was transferred to the Jai Prakash Narayan Apex Trauma Centre at AIIMS the same afternoon.

"The child was born to donate. He fought for eight days after suffering severe head injury. He had sustained severe head injury and CT scan showed irreversible severe damage to the whole brain," Dr Deepak Gupta, professor of neurosurgery at AIIMS, said.

He was declared brain dead on August 24.

The grief stricken family was counselled by the doctors and transplant coordinators of the Organ Retrieval Banking Organisation (ORBO) at AIIMS and they were informed about organ donation.

After counselling, the family agreed to donate his organs and tissues, doctors said.

The retrieval of organs began at 2am on Thursday and continued till 5am.

BJP MLA Raja Singh sent to jail

HYDERABAD: Suspended BJP MLA T. Raja Singh Lodh was sent to jail on Thursday after Hyderabad Police arrested him and invoked Preventive Detention (PD) Act. Police took the MLA into custody from his residence in Mangalhat amid tight security and continuing protests for his rearrest for allegedly making derogatory comments about Prophet Muhammad.

Raja Singh, who has been arrested for second time in three days, was later shifted to Cherlapally Jail on the city outskirts. The police announced that it has invoked PD Act against Raja Singh, a rowdy sheeter of Mangalhat Police



Station, on the orders of Hyderabad Police Commissioner C.V. Anand.

According to the police, Raja Singh has been habitually delivering provocative and inflammatory speeches and driving a wedge between communities leading to public disorder. A total of 101 criminal cases registered against him

since 2004. He was involved in 18 communal offences in the limits of different police stations in Hyderabad.

Rajasthan holds its breath as Gehlot considers move



HC refuses to stay Agnipath Scheme **NEW DELHI:** The Delhi

High Court Thursday refused to stay the Centre's Agnipath Scheme for recruitment in the armed forces and asked the central government to file its reply on a batch of petitions challenging the scheme. A bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad granted four weeks to the Centre to file the response.

The court asked the Centre to file a consolidated reply on petitions challenging the scheme and separate replies on those pleas which have challenged the recruitment processes in accordance with the previous advertisements in the Army, Navy, and Air Force before the introduction of the Agnipath Scheme.



Counsel for one of the petitioners urged the court to stay the operation of the scheme till the petitions are decided. The court, however, refused to stay the scheme saying that it was not passing any interim order and will hear the matter finally.

"We will not stay it. If you succeed you will get it," the bench orally said. Advocate Prashant Bhushan, appearing for some other petitioners, said the court may say that the appointment through the Agnipath Scheme will be subject to the outcome of the writ petitions. To this, the bench said, "it is always there".

Union Home Minister Amit Shah on Thursday reviewed the situation prevailing in Jammu and Kashmir, including the security arrangements along the border with Pakistan, officials said. National Security Adviser (NSA) Ajit Doval, Jammu and Kashmir Lieutenant Governor Manoj Sinha, Union Home Secretary Ajay Bhalla and senior officials of the Centre and the Union Territory administration attended the meeting chaired by Shah.

The meeting discussed the security situation in Jammu and Kashmir, an official said. The security review comes following attacks on security personnel, infiltration bids and killings in the Union Territory. Three infiltrators were killed by security personnel along the Line of Control (LoC) in the Kamalkote sector of Uri on Thursday. There have been at least three infiltration bids by terrorists from across the border in the last four days in Jammu and Kashmir.

HC refuses to stay Agnipath Scheme

NEW DELHI: The Delhi High Court Thursday refused to stay the Centre's Agnipath Scheme for recruitment in the armed forces and asked the central government to file its reply on a batch of petitions challenging the scheme. A bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad granted four weeks to the Centre to file the response.

The court asked the Centre to file a consolidated reply on petitions challenging the scheme and separate replies on those pleas which have challenged the recruitment processes in accordance with the previous advertisements in the Army, Navy, and Air Force before the introduction of the Agnipath Scheme.

ELHI HIGH COURT Counsel for one of the petitioners urged the court to stay the operation of the scheme till the petitions are decided. The court, however, refused to stay the scheme saying that it was not pass-

Some of the paintings have got damaged over a period of time due to this and other reasons, he said. "Hence, to save the paintings for a longer period of time, the way out is to restrict the footfall and allow fewer people inside the caves," Chauley said. He also said they can send only

40 tourists inside the caves at a time for a period of 10 minutes. In such a short span, the visitors cannot even see the paintings properly as they need time to get acclimatised to the darkness inside the caves, he added. There is an interpretation centre constructed by the state government outside the cave complex.
