Sub.: HOCL Replies on 18-11-2020 to BSE Mail dt. 17-11-2020 u/Ref. : Ref.: SOP-CReview-Nov20; - Fines as per SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020.

At the outset "wishing you all at BSE, a very happy and Prosperous New Year, 2021."

Further, we wish to place on record the following:-

- 1} That, we have already replied on 18-11-2020 in email to BSE giving out the details of BSE email letter dt.24-09-2020 regarding BSE waived off all the fines levied u//Regn.17 etc..., in reply to BSE email BSE Mail dt. 17-11-2020 regarding levy of fines thereof for non-compliances of Regn.17(1), followed with other Board Committees' related Regulations viz. Regns. 18, 19, 20 etc., consequent non-compliances with regard to the Composition of the Board of our Company. Scanned copies of the clarifications reply letter/email dt.18-11-2020 to BSE are enclosed herewith in the 2<sup>nd</sup> Attachments and for records please.
- 2} Further that, the referred non-compliances are only due to non- existence (since 21-02-2020 onwards) of any Independent Directors on our Company's Board, in view of the facts that our Company, HOCL being a CPSE/PSU, as per Company's Articles (AOA), all the powers to appoint Directors on the Company's Board vest with the Central Govt./GOI/Administrative Ministry.
- 3} We further submit that, considering our reasons (of non-compliances of Regn.17) and justifications as stated above, which we have been submitting to the Exchange (BSE) every quarterly in our Company's Corporate Governance (C.G.) Reports and from time to time whenever we receive from the BSE any levy of fines letter/s or emails, thereby requesting for the total waiver of fines levied etc., with the BSE Often /from time to time.
- 4} Accordingly, in response to our above stated reasons and justifications, BSE Officials, vide their email (letter) dt.24-09-2020 to us/our Company (HOCL) from the BSE Official, Mrs. Mangalam Iyer regarding BSE waiving off all the penalties levied under Regulation 17 and levied up to June, 2020 quarter for non-compliances u/Reg. 17 (1) viz. the Board of Directors -Composition due to non-existence of (any) Independent Directors on our Company's Board's composition- which obviously (consequently) follows the compositions of the other Board Committees, such as SRC, N&RC, Audit Committee etc. as all those Board Committees should also be adequately comprised of Independent Directors etc.....
