पर बच्ची अगस्त 2022 से राजकीय बाल गृह में रह रही है। पालनहार मां ने उच्च न्यायालय इलाहाबाद में बच्ची को अपनी रिपुदगी में लेने को याचिका दायर की है। इसमें 23 नवंबर को सुनवाई के दौरान शहर के व्यक्ति ने बच्ची के जैविक पिता होने का उच्च न्यायालय में दावा प्रस्तुत किया।
