Citing Section 45 of the Banking Regulation Act, 1947, Venkatachalam said the Government and the Reserve Bank of India (RBI) derived the powers, in public interest, to amalgamate any bank with another bank and thus avert closure of banks and consequent loss of deposits of the customers.

New Delhi, The opposition parties on Monday decided to support the Constitution Amendment to the OBC Bill, which is scheduled to be introduced in the Lok Sabha. Fifteen opposition parties met at the office of the Leader of Opposition in Rajya Sabha, Mallikarjun Kharge where the decision was taken after the meeting, Kharge said, "The opposition parties have decided that it will support The Constitution (One Hundred and Twenty-Seventh Amendment) Bill 2021 being introduced in Parliament today."

Volunteer for inquiry: SC refuses to stop CCI probe against Amazon, Flipkart

New Delhi, The Supreme Court on Monday declined to entertain a plea by e-commerce giants Amazon and Flipkart, saying they must face inquiry by Competition Commission of India (CCI) for anti-competitive practices. A bench headed by Chief Justice N.V. Ramana and comprising justices Vineet Saran and Surya Kant said: "Big organizations like you (Flipkart and Amazon) should volunteer for inquiry... Inquiry has to be conducted."

UP Cong launches 'BJP Gaddi Chhodo' campaign

Lucknow, The Congress on Monday launched a campaign against the ruling Bharatiya Janata Dal (BJP) in Uttar Pradesh. The campaign, called "BJP Gaddi Chhodo", has been launched on the anniversary of the 'Quit India Movement'. According to state Congress president Ajay Kumar Lallu, the party will hold various demonstrations including the marches in all Assembly constituencies over issues such as price rise, unemployment, farmers' plight and the law-and-order situation.

The bench said: "In the considered opinion of the court, appeals filed by appellants are devoid of merit and deserved to be dismissed..."
