IRCTC bring special pilgrim package



Varanasi, Nov 12: The Indian Railways Catering and Tourism Corporation (IRCTC) has introduced a special tourism package for devotees. The initiative was taken especially before Shivratri and the new year. This luxurious and economical tour package for religious trips will cover Varanasi and Nepal. The special tour package will start from Varanasi. The 5-day and 4-night tour includes travel via air to Nepal. In Kathmandu, the devotees will visit Pashupatinath Temple, Boudhanath Stupa, Durbar Square, Manakamana Temple in Pokhara, Vindhayavasi Temple, and Gupteshwar Mahadev Cave. This tour package will be operated from December 19 to December 23. The cost of the package is inclusive of direct flights from Varanasi to Nepal and back.

Tribal tourism in Dudhwa Tiger Reserve

UP, Nov 12: Uttar Pradesh, in an effort to boost eco tourism in the state, is going to introduce tribal tourism in Dudhwa Tiger Reserve. The tiger reserve comprises Dudhwa National Park, Kishanpur Wildlife Sanctuary and Katerniaghat Wildlife Sanctuaries, and this new initiative will take place near Katarniaghat Wildlife Sanctuary, in Bardiya village. Bardiya village is home to the Tharu tribe, one of the five tribes that are there in Uttar Pradesh. The people from this tribe live inside the tiger reserve and their village has been selected for the aforementioned tribal tourism. Through this initiative, visitors can learn so much about the life and culture of the Tharus. Also, the Tharu people will engage in ecotourism and will be able to put out their indigenous art and handicrafts to a wider audience. Dudhwa Tiger Reserve will officially reopen for the season on November 15, meaning, the tribal tourism initiative will also kickstart then. When we look at tribal tourism, we need to keep an open mind about a lot of things such as – there will not be world-class facilities and experiences, you will be experiencing a tribal village culture, and the roads may not be the most comfortable ones. But these are all a part of the experience and there are plenty of new things to learn from these types of tourism.
