Gist of proceedings of the 24th Extra-ordinary General Meeting (EGM)

- The 24th EGM of the Members of the Company was held on Friday, 1st December, 2023 at 11:30 A.M. through Video Conferencing ('VC' / 'Other Audio-Visual Means') ('OAVM').
- Shri Manoj Shambhu Dixit, Whole-time Director of the Company was appointed as the Chairman of the Meeting. The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman introduced the Directors, Key Managerial Personnels and other senior officials who had joined the meeting.
- The Chairman informed that remote e-voting commenced from Monday, 27th November, 2023 at 9.00 A.M. (IST) and ended on Thursday, 30th November, 2023 at 5.00 P.M. (IST). Further, the facility for e-voting during the EGM was also provided to the Members of the Company.
- A fair opportunity was given to the Members of the Company to seek clarifications and/ or offer comments on the item of the business to be transacted at the Meeting.
- The Chairman briefed the Members, inter-alia, on the items to be transacted at the EGM.





The following item of business as set out in the Notice calling the Meeting was proposed for Members' approval through e-voting (i.e. remote-voting facility):

- ➤ Approval of Material Related Party Transactions
- The Chairman announced that the e-voting results (i.e. result of remote e-voting together with that
 of the e-voting conducted at the EGM) along with the Scrutinizer's Report, shall be displayed on

 https://www.evotingindia.com/; and websites of Stock Exchanges, where the equity shares of the
 Company are listed i.e. on BSE and NSE, within 2 working days of the conclusion of the Meeting.
- The Chairman then thanked the Members for attending the EGM through Video Conferencing and declared the meeting as concluded. At the time of conclusion of EGM, the Chairman announced that the e-voting facility provided during the EGM shall remain open for next 15 minutes after the conclusion of the EGM.
