This is with reference to your email dated July 2, 2021 regarding non-submission of financial results for the quarter and year ended March 31, 2021 pursuant to compliance of Regulation 33 of SEBI (LODR) Regulations, 2015.

We regret that Financial Results has not been submitted by us within the extended deadline by 30.06.2021 as allowed by SEBI vide Circular No. SEBI/HO/CFD/CMD1/P/ CIR/2021/556 dated 29.04.2021. We would like to inform you that due to spread of second wave of COVID-19 pandemic, we could not prepare and submit Audited Financial Results (Standalone and Consolidated) for the quarter and year ended 31st March, 2021 within time allowed. Pandemic has created significant barriers or limitations which has prohibited us from getting access to the key information which is needed for preparation of the financial statements, related transactions reports etc.

Meanwhile, our CFO, Sri A. K. Singhania was tested Covid Positive on 24.04.2021. As incharge of finance and accounts functions of the Company, the CFO has important role in finalizing the Financial Results of the Company. He was not in a position to support and work for finalization of Financial Results of the Company. Our Registered Office and majority of Plants are located in West Bengal and Government of West Bengal has declared lockdown with effect from 16th May, 2021 and has further extended the same from time to time and same is still in force up to 15.07.2021. During lockdown necessary measures have been taken to cut down the mobility of people and limiting human contact through assembly and congregation. We are facing difficulties in compilation of figures from our various branches and getting done audited the same. There are various restrictions on the movement of employees as well as working hours. The Statutory Auditors of the Company as well as that of subsidiaries also require a reasonable period of time in order to complete the Audit process and issue their Report on the Financial Statements as their offices are either closed or working with reduced capacity.



Inconclusive	The presence of RNA specific to SARS-CoV-2 is not certain. Repeat sampling and testing is recommended

Note:

- ICMR Registration Number for COVID-19 testing: LAMEPLHWB
- The test is conducted using the kits and viral transport media (VTM) approved by ICMR/USFDA
- SARS-CoV-2 RT PCR test is an in vitro test for qualitative detection of Novel Corona Virus 2019 in upper respiratory tract specimens. All results of the test should be correlated with clinical findings.
- Positive results denote the presence of concerned RNA in the tested specimens
- A single negative test result, particularly from the upper respiratory tract specimen, does not preclude Covid-19 infection. Negative results may be attributed to insufficient viral RNA in the sample, presence of mutant strain of the virus, and/or the presence of inhibitors.
- Kindly consult referring physician / authorized hospital for appropriate follow up.
