**EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013 ("ACT") IN RESPECT OF SPECIAL BUSINESS SET OUT IN THE NOTICE**

**Item Numbers 1 to 6:**

As the Members are aware, the Company had already sought approval from its Members by way of special resolutions on the said Item Numbers 1 to 6 by and under its Postal Ballot Notice dated 18<sup>th</sup> March, 2019 ("**First Postal Ballot Notice**"). The Company had, on 26<sup>th</sup> April, 2019, declared the results of the said voting together with the Scrutinizers' Report, and the resolutions set out in Item Nos. 1 to 6 had been duly passed by the requisite majority by way of Special Resolutions.

Based on complaints received by it, the Securities and Exchange Board of India ("SEBI") had, on 23<sup>rd</sup> April, 2019, passed a direction on the Company not to act on any of the transactions set out in the First Postal Ballot Notice, till further directions from SEBI. Thereafter SEBI, passed its order dated 23<sup>rd</sup> July, 2019 and clarificatory order dated 30<sup>th</sup> July, 2019 (collectively "**SEBI Order**") in respect of the said complaints. It observed, among other things, that "*It is noted that the transaction involving sale of hotel properties is between HLVL and Brookfield, which is not a 'related party' and the consideration for the same is to be paid by Brookfield to HLVL. Further, it is noted that there is no transfer of 'resources, services or obligations' of any kind between HLVL and any of the Promoters. Therefore, it is noted that the Company's transactions do not fall within the ambit of 'related party transactions' as defined under the LODR Regulations 2015.*" In the SEBI Order, SEBI has observed that certain additional disclosures should have been made by the Company, and accordingly SEBI has *inter alia* directed the Company to once again seek the approval of the members of the Company in respect of the transactions set out in Item Numbers 1 to 6 above, while making such additional disclosures as directed in the SEBI Order.

Pursuant to the SEBI Order, the Board of Directors of the Company had a meeting on 10<sup>th</sup> August, 2019 and discussed the SEBI Order. Based on a review of the said order, the recommendations of the Audit Committee, and in line with its decision taken at its meeting on 18<sup>th</sup> March, 2019, the Board continued to remain of the unanimous view that the sale by the Company of its undertakings to Brookfield should proceed as originally approved in its meeting held on 18<sup>th</sup> March, 2019 and accordingly, noted with approval that the resolutions passed by it in its meeting held on 18<sup>th</sup> March, 2019 continued to remain valid. The Board considered this Postal Ballot Notice and Explanatory Statement ("**PBN**") and all the documents referred to in the PBN and unanimously approved the same and resolved once again to recommend the said resolutions for approval by the shareholders.

Accordingly, and in compliance with the SEBI Order, the Company is now once again seeking approval of the members of the Company for the transactions set out in Item Numbers 1 to 6 above. Pursuant thereto, as a matter of good order and for ease of reference, set out below is the Explanatory Statement as annexed to the First Postal Ballot Notice.

**Original Explanatory Statement as contained in the Postal Ballot Notice dated 18<sup>th</sup> March, 2019 (First Postal Ballot Notice)**

As the Members are aware, the Company had restructured its debts under the Corporate Debt Restructuring ("CDR") mechanism in September 2012 with January 1, 2012 as the cut-off date. The Company has been seeking a viable restructuring package from its lenders, but it did not materialize.

In order to reduce debts, the Members had passed a special resolution in December 2014 for sale of Leela Palaces and Resorts Limited ("LPRL"), a wholly-owned subsidiary of the Company, together with the property owned by the said subsidiary in Agra. The Members also had passed special resolutions in September 2016 for sale of the Hotels owned by the Company in Delhi and/or Chennai. However, the Company could not conclude the sale of any of the aforesaid properties.

The Company has been evaluating various options for a viable restructuring, including sale/ monetization of non-core assets, sale of hotels, equity infusion and debt refinancing by investors.

In this regard, the Company has received a proposal from BSREP III India Ballet Pte. Ltd., a company incorporated in Singapore and an affiliate of BSREP III, Brookfield Asset Management's (NYSE: BAM) latest flagship private real estate fund, which globally owns and operates \$350 billion of assets, with interests in various sectors ("Brookfield") for acquiring (i) the Company's hotel undertakings in Delhi, Bengaluru, Chennai and Udaipur; (ii) the Company's business of hospitality and hotel management operations together with all intellectual property of the Company used in, held for use in, or related to the hospitality, hotels and resorts business or related to the Undertakings (as defined below); and (iii) the shares of LPRL, which owns certain property and holds licenses for the development of a hotel in Agra, through various subsidiaries (direct or indirect) or affiliates of Brookfield (each, a "Purchaser Entity") as they intend to engage in the hospitality business in India. It is a composite proposal for the acquisition of the aforementioned hotels and related assets, as well as the "The Leela" brand and other associated brands and intellectual property rights as mentioned herein. Brookfield, through the Purchaser Entities, will purchase and consummate all of what is mentioned herein simultaneously. If any one of the transactions mentioned herein are not consummated, the entire transaction will fail and therefore, each and every aspect of the transaction described below is connected, interlinked and integral for the entire transaction to close.

In order to consummate the above transaction, it is now proposed to sell the Company's hotel undertakings (other than the Company's hotel in Mumbai) and the business of hotel management operations and all the shares of LPRL to the Purchaser Entities, in the following manner ("Transaction"):

- (a) The hotel undertaking of the Company located in Delhi is proposed to be transferred by way of a slump sale, as a 'going concern' to a Purchaser Entity, for a lumpsum consideration of ₹1,705 Crores, subject to adjustments, if any ("Delhi Hotel Undertaking");
- (b) The hotel undertaking of the Company located in Bengaluru is proposed to be transferred by way of a slump sale, as a 'going concern' to a Purchaser Entity, for a lumpsum consideration of ₹1,000 Crores, subject to adjustments, if any ("Bengaluru Hotel Undertaking");
- (c) The hotel undertaking of the Company located in Chennai is proposed to be transferred by way of a slump sale, as a 'going concern' to a Purchaser Entity, for a lumpsum consideration of ₹675 Crores, subject to adjustments, if any ("Chennai Hotel Undertaking");
- (d) The hotel undertaking of the Company located in Udaipur is proposed to be transferred by way of a slump sale, as a 'going concern' to a Purchaser Entity, for a lumpsum consideration of ₹ 320 Crores, subject to adjustments, if any ("Udaipur Hotel Undertaking");
- (e) The undertaking of the Company pertaining to the hotel/ project management operations of the Company (including the hotel management contracts and technical service agreements in relation to hotels/serviced apartments at Gurgaon, Delhi, Cavelossim, Kovalam, Hyderabad, Mumbai, Bengaluru, Gandhinagar), together with all intellectual property of the Company used in, held for use in, or related to the hospitality, hotels and resorts business or related to the Undertakings (as defined below), is proposed to be transferred by way of a slump sale, as a 'going concern' to a Purchaser Entity, for a lumpsum consideration of ₹ 135 Crores, subject to adjustments, if any ("Hotel Operations Undertaking"); and
- (f) The entire shareholding of Leela Palaces and Resorts Limited ("LPRL"), which owns property in Agra and holds licenses for the development of a hotel, held by the Company is proposed to be transferred to a Purchaser Entity for a total consideration of ₹ 115 Crores.

Each of the aforementioned hotel undertaking set forth in items (a) to (e) are proposed to be transferred as a going concern on a 'slump sale' basis (as defined under Section 2(42C) of the Income Tax Act, 1961) for a lumpsum consideration, without values being assigned to individual assets and liabilities, based on certain representations, warranties and indemnities provided by the Company. Each hotel undertaking for the purpose of such transfer would comprise all undertakings of the Company pertaining exclusively to the relevant hotel, including the transfer of all its movable assets, immovable assets,

liabilities, customer contracts, vendor contracts, properties, permits and licenses, employees and employee benefit funds, bookings/reservations made by customers, and records pertaining to the relevant hotel undertaking. The windmills owned by the Company in Karnataka and Tamil Nadu are also being transferred as part of the Bengaluru Hotel Undertaking and the Chennai Hotel Undertaking, respectively. The employees of each hotel undertaking shall be transferred to the relevant Purchaser Entity with full continuity of service and on terms no less favourable in the aggregate than the terms on which they are currently employed with the Company. A post-closing working capital adjustment is also envisaged in the transfer of each hotel undertaking. As part of the Transaction, the Company and the Promoters of the Company have agreed to certain exclusivity, non-compete and non-solicit restrictions.

The completion of the Transaction is subject to fulfilment of certain conditions precedent including, *inter alia*, receipt of the approval of the lenders of the Company, receipt of the approval of shareholders of the Company by way of special resolution and other regulatory approvals, as applicable, as well as the condition that all security created by or over the assets of the Company and/or the Promoters / Promoter Group in favour of the lenders of the Company are to be released upon and as a part of closing of the Transaction. The entire transaction is subject to lenders' approval and in fact, the Company has already submitted the necessary documents for evaluation by lenders and approval by them.

As a part of the Transaction, the Company has, on 18<sup>th</sup> March, 2019, entered into a Framework Agreement with Brookfield, among others, to record the understanding of the parties in relation to the contemplated Transaction ("**Framework Agreement**"), and, in addition the Company will execute separate Business Transfer Agreements ("**BTAs**"), as well as various supplementary and ancillary agreements, for the transfer of the Bengaluru Hotel Undertaking, Chennai Hotel Undertaking, the Delhi Hotel Undertaking, the Udaipur Hotel Undertaking, and the Hotel Operations Undertaking (collectively the "**Undertakings**") as part of their transfer on a slump sale basis as a going concern which will also include agreements for assignment of all intellectual property used in, held for use in, or related to the hospitality, hotels and resorts business or related to the Undertakings and agreements for the conveyance of immovable property in relation to the Undertakings. The Company will also execute a separate share purchase agreement with a Purchaser Entity for the sale of the entire 100% shareholding of the Company in LPRL. Further, the Company will provide transition support to the Purchaser Entity through, *inter alia*, limited licenses for the use of office space for a transition period and other support services as may be mutually agreed. In addition, Brookfield will have a right of first refusal over the Company's hotel in Mumbai, as a part of the transaction.

Voting and exclusivity agreements with *inter alia* the Promoters have also been entered into, where relevant members of the Promoter / Promoter group have provided their express consent to vote in favour of the resolutions contained in this notice in such manner so as to give effect to, and prescribing the manner of dealing with competing offers in relation to, the transaction.

In addition to the above, for the consummation of the Transaction, the following additional agreements are proposed to be entered into:

- (a) An escrow agreement will be entered into between Brookfield, the Company and its lenders, which will provide for the total consideration payable for the Transaction being deposited by Brookfield/ the relevant Purchase Entities in an escrow account which will be used for repayment of the loans taken by the Company from such lenders. Simultaneous with such repayment, there will be a corresponding release of all mortgages/security interests created by the Company and its Promoters / Promoter Group in favour of such lenders and the Company's assets, including the Mumbai Hotel, which will then be free from all mortgages/security interests.
- (b) An agreement for assignment will be entered into by Leela Lace Holdings Private Limited ("**LLHPL**") and a Purchaser Entity, for assignment of the intellectual property owned by LLHPL used in, held for use in or related to the hospitality, hotels and resorts and business, as may be mutually agreed between the Purchaser Entity and LLHPL, for a total consideration of ₹ 150 Crores (Indian Rupees One Hundred and Fifty Crores).
- (c) An agreement for the license of the right to use the name "The Leela" with respect to the hotel operated by the Company in Mumbai, and related matters, and also an agreement for use of centralized services to be provided by Brookfield in this respect.
- (d) An agreement to be entered into between Brookfield and certain Promoters / members of the Promoter Group (or their affiliates) with respect to business expansion services to be provided to Brookfield, whereby the said Promoters / members of the Promoter Group (or their affiliates) would provide services and may receive consideration up to an amount of ₹ 150 Crores (Indian Rupees One Hundred and Fifty Crore), subject to due performance of the terms and achievement of the milestones set out therein.
- (e) As the Bengaluru Hotel Undertaking is built partly on the land leased from Leela Lace Holdings Private Limited, as a part of the transfer of the Bengaluru Hotel Undertaking, there will be a fresh lease deed to be executed with respect to the grant of leasehold rights with respect to the Bengaluru Hotel Undertaking land which is owned by LLHPL, initially on

the same rent as currently being paid by the Company. This agreement also grants to Brookfield a right of first refusal for the acquisition of the Bangalore hotel land.

- (f) Given that Promoters own "The Leela" brand *inter alia* in respect of real estate projects, Brookfield and certain Promoters will enter into a joint venture agreement for the development of real estate projects using the said brand.
- (g) An intellectual property assignment agreement to be executed between the Promoters / Promoter Group and their affiliates and LLHPL as may be mutually agreed between the parties and Brookfield.
- (h) An intellectual property assignment agreement between the Company and identified promoters and their affiliates, with respect to registrations/ applications for registration of the trademark 'Jamavar', as may be mutually agreed between the parties and Brookfield.

Pursuant to the foregoing, the Audit Committee of the Company, at its meeting held on 18<sup>th</sup> March, 2019, has approved and recommended the Transaction to the Board of Directors. Pursuant thereto, the Board of Directors of the Company, at its meeting held on 18<sup>th</sup> March, 2019 has approved the Transaction, subject to the approval of the members and other requisite approvals and also subject to the fulfillment of various conditions, including that all security created by or over the assets of the Company and/or the Promoters / Promoter Group in favour of the lenders of the Company are to be released upon and as a part of closing of the Transaction. The Board of Directors has further accorded its approval for the execution of relevant transaction documents for giving effect to the above. The agreements and documents referred to in the postal ballot notice and explanatory statement are available for inspection.

In terms of Section 180(1)(a) of the Companies Act, 2013 ("Act") a company shall not, except with the consent of the members by way of a special resolution, sell, lease, or otherwise dispose of the whole, or substantially the whole, of the undertaking of the Company in which the investment of the Company, exceeds 20% of its net worth as per the audited balance sheet of the preceding financial year or 20% of the total income of the company during the previous financial year.

In addition, Regulation 24 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR") provides that no company shall dispose of shares in its material subsidiary which would reduce its shareholding (either on its own or together with other subsidiaries) to less than 50% or cease to exercise of control over the subsidiary without passing a special resolution in its General Meeting, except in cases where such divestment is made under a scheme of arrangement duly approved by a Court/ National Company Law Tribunal.

The net worth of the Company as on 31<sup>st</sup> March, 2018 is ₹ 48.30 Crores and the consolidated turnover of the Company for the financial year is ₹ 743.13 Crores.

LPRL is a material subsidiary of the Company as its net worth exceeds 20% of the consolidated net worth of the Company in the immediately preceding accounting year.

Since the proposed Transaction involves transfer/sale of the various Undertakings as mentioned above, as well as sale of shares held by the Company in LPRL, which exceeds 20% of the net worth of the Company as per the last audited balance sheet and also exceeds 20% of the total income of the Company during the previous financial year, the transactions mentioned under resolution Nos. 1 to 6 require the approval of the shareholders of the Company, as per the provisions of the Act/ LODR.

The proceeds of the Transaction would be used in accordance with the provisions of the transaction documents to repay the existing lenders of the Company, and upon closing, all the borrowings of the Company from all banks and financial institutions would have been repaid. The Company will continue to have and operate the hotel in Mumbai, certain land in Hyderabad (valued at about ₹ 40 Crores) and the joint development project of residential apartments with Prestige Developers in Bangalore (the balance value of which is about ₹ 90 Crores).

None of the Directors/ Managers/ Key Managerial Personnel of the Company and their relatives is/ are, in any way, concerned or interested in the said resolutions, except to the extent stated above, and also to the extent of their respective shareholdings in the Company, if any, and such other additional obligations that they are required to fulfill in order to complete the transaction.

The Board of Directors recommend to the members passing of these resolutions as special resolutions, through Postal Ballot.

#### **Additional information**

The audited accounts for the year ended 31<sup>st</sup> March, 2019 have been approved by the Board at its meeting held on 27<sup>th</sup> May, 2019 and are being placed for approval before the shareholders at the ensuing annual general meeting proposed to be held on 19<sup>th</sup> September, 2019. As per the said audited accounts, the consolidated turnover of the Company as on 31<sup>st</sup> March, 2019 was ₹ 762.5 Crore, which includes the turnover of the hotel undertakings proposed to be sold by the Company, and classified as "asset included in disposal group(s) held for sale".

### Valuation

Sale of the Company's Hotel Undertakings in New Delhi, Bangalore, Chennai and Udaipur

The following valuation reports had been obtained in 2014 (a) individual valuation reports dated 8<sup>th</sup> April, 2014 from Crowe Horwath HTL Consultants Private Limited ("Horwath"), with respect to each of the Company's hotels in New Delhi, Chennai

and Udaipur as at 1<sup>st</sup> April, 2014; and (b) valuation report dated 23<sup>rd</sup> July, 2014 from Horwath with respect to the Company's hotel in Bangalore as at 1<sup>st</sup> April, 2014 (collectively "2014 Valuation Reports"). The valuation methodologies applied in the 2014 Valuation Reports are the Discounted Cash Flow method and the Replacement Cost Method.

Furthermore, the Company had made an application to its lenders on 20<sup>th</sup> March, 2019, seeking their approval for the proposed sale by the Company of its Undertakings to Brookfield and prior to the issuance of the Postal Ballot Notice dated 18<sup>th</sup> March, 2019, the Company had submitted the necessary documents for evaluation by lenders and approval from them. Pursuant thereto, certain lenders asked the Company to obtain valuation reports with respect to the Company's hotels in New Delhi, Bangalore, Chennai and Udaipur as at 31<sup>st</sup> March, 2019 from valuers who are empanelled as such with the lenders. Accordingly, the Company has obtained the following: (a) individual valuation reports dated 18<sup>th</sup> April, 2019 for each of the Company's hotels in New Delhi, Chennai and Bangalore from Sapien Services Private Limited; and (b) valuation report dated 12<sup>th</sup> April, 2019 of the Company's hotel in Udaipur from Mr. Mukesh Dad, Chartered Engineer (collectively "2019 Valuation Reports"). The valuation methodologies applied in the 2019 Valuation Reports are the Fair Market Value method, the Realisable Value method and the Distress Sale Value Method (except for the 2019 Valuation Report for Udaipur, which only applies the Replacement Cost method).

Set out below is a table which shows the value of the Company's hotels in New Delhi, Bangalore, Chennai and Udaipur under the 2014 Valuation Reports, 2019 Reports and the final price agreed to be paid by Brookfield.

The following observations are relevant with respect to the 2014 Valuation Reports:

- One part of the 2014 valuation relied on the Discounted Cash Flow (DCF) method of valuation, which essentially relies on projections of future revenue. These reports were made available to prospective investors / buyers including Brookfield, from time to time. However, in the 4 years which have passed from the date of the valuation, the actual revenues and profit did not correspond to the assumed projections due to prevailing economic condition, and therefore, the prospective investors / buyers would likely have made offers after adjusting for the difference in profit.
- In any event, the price being offered for the Delhi Hotel by Brookfield is actually higher than the DCF valuation, and the price offered for the Bangalore and Udaipur Hotels by Brookfield is quite similar to the DCF valuation, and it is only with respect to the Chennai hotel there is deviation in price offered. However, it is worth noting that the total price offered by Brookfield for all the 4 hotels is higher than the DCF Value of the 4 hotels.
- In addition, the price being offered for the Delhi and Udaipur Hotels by Brookfield is quite comparable to the Replacement Cost valuation. With respect to the Bangalore Hotel, the price offered by Brookfield is higher than the Replacement Cost Valuation, excluding the land value. It is only with respect to the Chennai Hotel, that price offered by Brookfield is lower than the Replacement Cost Valuation.

With respect to the 2019 Valuation Reports, even though the same have been obtained after the 18<sup>th</sup> March, 2019 Board Meeting, the same bear out and vindicate the decision made, as the values ascribed to such hotel assets are lower than the offer received from Brookfield, and the distress values as set out in the 2019 Valuation Reports are in fact much lower than the Brookfield offer.

#### Sale of the Hotel Operations Undertaking

Horwath have done a valuation of the Management Contracts Business, i.e., managing hotels owned by other parties, under a management contract, taking into consideration the discounted cashflows of the revenue from the four hotels presently under management and the three hotels under development. Based thereon, in Horwath's opinion, the valuation of the Management Contracts Business is in the range of ₹ 115.13 Crore to ₹ 141.67 Crore. Brookfield's offer is an amount of ₹ 135 Crore, which falls within the valuation range specified by Horwath.

#### Sale by the Company of its 100% shareholding in LPRL

M/s Ishwar & Gopal, Chartered Accountants, have conducted a valuation of LPRL, and in their opinion the value of 100% shareholding in LPRL is ₹ 114.39 Crore. Brookfield's offer of ₹ 115 Crore is higher than the said valuation.

#### Provision of license to use the name "The Leela" and provision of centralized services

As mentioned above, there is no license fee payable by the Company to Brookfield for the license to use the name "The Leela". The annual centralised services cost is variable and depends on the estimated budget of costs. Most centralized services will be provided at cost, and the remaining will be provided on a cost plus 10% basis. Horwath, having regard to the above, have stated that, in their opinion, the charges proposed to be paid by the Company, when taken as a percentage of the total revenue of the Mumbai hotel, are within the industry norms.

#### Sale by various Promoters / members of the Promoter Group of "The Leela" brand

A valuation of "The Leela" brand, which is owned by the Promoters, adopting the royalty based approach, for the purpose of valuation of the brand for the purposes of possible sale, was undertaken by Horwath in 2017 ("**Leela Brand Valuation Report**"). The Leela Brand Valuation Report highlights the fact that the Company was not charged any royalty by the Promoters / members of the Promoter Group for use of "The Leela" brand, whereas a hotel would normally have been charged a brand or license fee for use of the brand. The computation of the brand value is on the assumption that the brand related fee that could have reasonably be charged by Leela hotels would be 1.5% of total revenue. Accordingly, the estimated brand value as per Horwath is approximately ₹ 500 Crore, and the Promoters are receiving a lesser amount than this from Brookfield.

#### Provision of business expansion services by the Promoters

As mentioned above, an amount of up to ₹ 150 Crore may be paid by Brookfield to the Promoters under this Agreement, over a period of time, subject to due performance of the terms and achievement of the milestones set out therein. Further to the SEBI Order, a valuation report was sought in respect of such services from Horwath. However, Horwath have informed that a valuation of such services is not possible.

#### Lease by LLHPL to Brookfield of the Bangalore hotel land

With respect to the lease by LLHPL to Brookfield of the Bangalore hotel land, Colliers International have submitted a Valuation Report, and in their view an amount of ₹ 37.13 per square foot per month is the fair market rent of the said land. Given the land area is approximately 24,404 square meters (equivalent to approximately 2,62,682 square feet), this works out to approximately ₹ 97.53 lakh per month, and approximately ₹ 11.7 Crore per year. The amount agreed to be paid by Brookfield to LLHPL, which is a promoter group company, is lower than this.

#### Grant of license to use the "Jamavar" trademarks by Brookfield to the Promoters

Horwath has undertaken a valuation of the "Jamavar" brand based on the discounted cash flow of the royalty which would have been payable if such brand were owned by a different entity. Based on this, Horwath have valued the "Jamavar" brand to be in the range of ₹ 10.39 Crore to ₹ 14.24 Crore.

#### Joint venture / collaboration for residential real estate projects using the "Leela" brand

The Promoters / members of the Promoter Group and Brookfield have agreed to collaboratively pursue the business of "Leela" branded residential real estate projects. Given that both Promoters / members of the Promoter Group as well as Brookfield will have rights to do certain types of "Leela" branded residential projects, rather than dilute the brand by separately undertaking such projects, the parties have agreed to collaboratively pursue such branding business since both parties have the potential to achieve synergies in this business through such a collaboration. This collaboration arrangement does not currently have any projects and shall come into effect only as and when any projects are identified and undertaken in the future. Neither the Promoters / members of the Promoter Group nor Brookfield are paying any consideration to each other in this regard, and only future revenues, if any, shall be shared between them as aforesaid. Accordingly, there is no valuation which could have been obtained in this respect.

#### Liability to AAI

The Company had entered into a lease deed on 7<sup>th</sup> February 1996 with the Airports Authority of India ("**AAI**") in respect of land admeasuring 11,000 sqm ("**Leased Property - 2**") next to The Leela, Mumbai ("**Mumbai Hotel**"), intended for the construction of a 150-room Hotel based on terms stipulated in it of ground rent and royalty on turnover with minimum guaranteed amounts ("**MG**") to be mutually agreed. The percentage of royalty and MG was stipulated in the Supplementary Agreement dated 7<sup>th</sup> February, 1996 entered into between AAI and the Company ("**Supplementary Agreement**"). The MG was arrived at based on certain revenue projections.

The terms and stipulations specified in the Supplementary Agreement became impossible of performance for various reasons and the Company has disputed the same. Further, the Company vide letter dated 6<sup>th</sup> April 2017 requested AAI to take over immediate physical possession of the Leased Property - 2 pending restoration of floor space index ("**FSI**") by the Company. However, AAI commenced the eviction proceedings with their claim of MG and enhanced rent. As per the



revised claim filed by AAI in February 2019 before the eviction officer, the amount due to them as on 31<sup>st</sup> January, 2019 is ₹ 807.05 Crore towards MG and rent as against ₹ 285.37 Crore as on 31<sup>st</sup> January, 2017 claimed earlier, which the Company is disputing. The eviction matter is pending with the eviction officer and the Company is legally contesting the same. According to legal opinion received, the liability is contingent in nature and hence no provision is made in the books. No provision has been made for the cost of FSI in the books of account, as it is not ascertainable.

There were lease agreements dated 19<sup>th</sup> October, 1983 and 22<sup>nd</sup> November, 1983 between AAI and the Company relating to the Mumbai Hotel for the lease of 18,000 square meters of land ("**Leased Property - 1**") which were valid till 11<sup>th</sup> July, 2012 and vide letter dated 31<sup>st</sup> March, 2011, AAI had offered to extend the lease of Leased Property - 1 by another 30 years, subject to revised terms, which the Company had accepted vide its letter dated 29<sup>th</sup> September, 2011. Pending execution of the lease agreement, AAI had been provisionally extending the lease for 3 months to 1 year at a time and the latest extension was till 11<sup>th</sup> January, 2016. Thereafter, AAI arbitrarily increased the lease rental payable for Leased Property - 1, effective from 1<sup>st</sup> October, 2014, and the increased rentals on the basis of such arbitrary increase works out to ₹ 51.84 Crore for the period up to 31<sup>st</sup> March, 2019. The Company has objected to this increase and has not provided for the same. AAI has unilaterally terminated the lease and commenced eviction proceedings and the Company is legally contesting the same.

While the approval of members for the transactions with Brookfield was in process, AAI had, after the issuance of the First Postal Ballot Notice on 18<sup>th</sup> March, 2019 filed a suit before the Hon'ble City Civil Court at Dindoshi, being Short Causes Suit No. 845 of 2019 ("**Suit**"), against the Company, its directors, Promoters/ members of the Promoter Group, JM Financial Asset Reconstruction Company Limited and ITC Limited ("**Defendants**"), seeking (i) a declaration that the act of the Defendants in trying to dispose of / create third party rights in respect of any assets of the Company, except the Mumbai property, in any manner whatsoever, is fraudulent and being done to defeat the right of AAI; (ii) an order of injunction restraining the Defendants from creating any kind of third party rights in respect of any assets of the Company, till such time the vacant and peaceful possession of the Leased Property - 2 is handed over to AAI, along with FSI as on the date of handing over of possession to the Company; (iii) an order of injunction restraining the Defendants from creating any kind of third party rights in respect of any assets of the Company, till such time the dues of AAI are paid by the Company. It also filed a Notice of Motion seeking certain interim reliefs till the hearing and final disposal of the Suit. The said Notice of Motion was dismissed by the Hon'ble City Civil Court at Dindoshi, vide its order dated 12<sup>th</sup> June, 2019, and there is currently no order in the Suit which is operating against the Company or which prevents the consummation of the transactions set out above.

#### **Transaction relating to Jamavar**

The SEBI Order, *inter alia*, directed that the transaction "*involving transfer of 'Jamavar' trademark, shall separately be put to vote by HLVL before its shareholders afresh, in case such valuation in respect of the 'Jamavar' trademark exceeds 10% of the annual consolidated turnover of HLVL, as per the last audited financial statements.*" As mentioned above, the valuation of the 'Jamavar' trademark is in the range of ₹ 10.39 Crore to ₹14.24 Crore. As mentioned above, the annual consolidated turnover as per the audited financial statements of the Company for the year ended 31<sup>st</sup> March, 2018 is ₹ 743.13 Crore, and 10% of the said amount is ₹ 74.3 Crore. As also mentioned above, the annual consolidated turnover as per the audited financial statements of the Company (approved by the board but not yet placed before the shareholders) for the year ended 31<sup>st</sup> March, 2019 is ₹ 762.5 Crore, and 10% of the said amount is ₹ 76.25 Crore. Accordingly, given that the valuation of the 'Jamavar' trademark is much lower than 10% of the annual consolidated turnover for both the year ended 31<sup>st</sup> March, 2018 as well as the year ended 31<sup>st</sup> March, 2019, as per the SEBI Order, the said transaction is not being separately put to vote by the Company before its shareholders.
