We, **M/s RMG & Associates**, Company Secretaries, have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **Next Mediaworks Limited**, (hereinafter referred as ‘**the listed entity**’), having its Registered Office situated at Unit 701 A, 7th Floor, Tower 2, Indiabulls Finance Centre, Senapati Bapat Marg, Elphinstone Road, Mumbai- 400013 and Corporate Office situated at Hindustan Times House (2nd Floor), 18-20, Kasturba Gandhi Marg New Delhi - 110001.
