Subject: Allotment of Equity Shares

Dear Sir/Madam,

In terms of the Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "LODR"), we would like to inform you that the Board of Directors of the Company vide a resolution passed by way of circulation on Wednesday, July 10, 2024, approved the allotment of 6,000 (Six Thousand) Equity Shares having face value of Rs. 10 (Rupees Ten only), pursuant to the ESOP option exercised by the employee under QDL ESOP Plan 2020. These shares shall rank pari passu with the existing equity shares of the Company in all respects.

Consequently, the paid-up capital of the Company has increased from existing Rs. 47,13,60,080 divided into 4,71,36,008 equity shares of Rs. 10 each to Rs. 47,14,20,080 divided into 4,71,42,008 equity shares of Rs. 10 each.

The Company has already received the in-principle approval from BSE for listing and is in the process of applying for the final listing approval of the above shares on BSE.

Pursuant to the Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, the disclosure of specified information in respect of abovementioned event is annexed hereto and marked as **Annexure** -1.

Directors of the Group, whether whole-time or not but excluding independent directors. such other employees and persons as may be permitted under the applicable laws and as may be approved by the Board, from time to time. As per the QDL ESOP PLAN 2020, ESOPs will vest on completion of minimum of 1 (One) year from the date of the Grant and it may extend maximum up to 10 (Ten) years from the date of grant of Options or such other period as may be decided by the Committee. Further in accordance with ESOP plan, vesting criteria can be decided by the Compensation committee.
