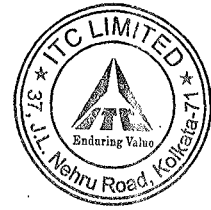

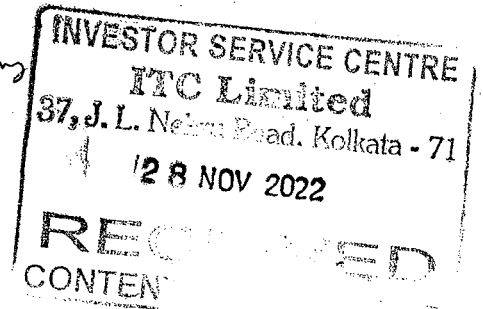
Sir,
