

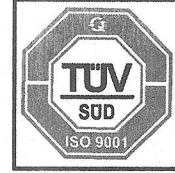

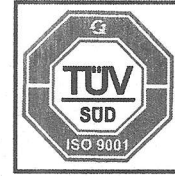

Independent Auditor's Report

To the Members of

Report on the Financial Statements

OPINION

We have audited the accompanying Ind AS financial statements of **ALFA TRANSFORMERS LIMITED** ("hereinafter referred to as the Company") comprise the Balance Sheet as at March 31, 2022, the Statement of Profit and Loss, including the statement of Other Comprehensive Income, the Cash Flow Statement and the Statement of Changes in Equity for the year then ended, and a summary of significant accounting policies and other explanatory information.

Basis for Opinion

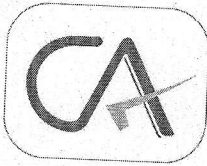

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

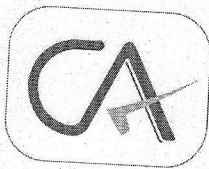

The Company's net worth is eroded substantially due losses incurred by the company and the management is also in consideration of sale of its Vadodara Unit.

We were informed by the management, that the company's inflow of fund from sale of Vadodara Unit and operating income from Unit-1 Bhubaneswar shall be sufficient for future survival and running of the Company .

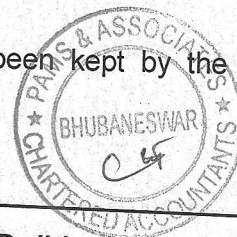
2. Confirmation of Debtors and Creditors :

In some of the cases the party conformation from Sundry Debtors and creditors specifically from Gujurat Power sector companies are yet to be received as on 31-03-2022 due to Covid-19 situation as explained to us by the management. The Debtors/ creditors balances have been considered as per the figures appearing in the books of accounts of the Company.

Our opinion is not qualified in respect of these matters.
