

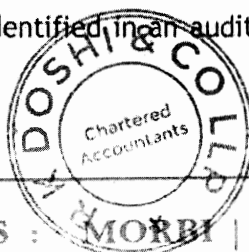

We did not review the interim financial results of one subsidiary company included in the statement / result whose interim financial results (before eliminating inter-company balances/transactions) reflect total assets of Rs. 869.77 Lakhs as at 30<sup>th</sup> June, 2020 and total revenue of Rs. 97.71Lakhs, total net profit/(loss) after tax of Rs.0.61Lakhs and total comprehensive income of Rs. 0.61Lakhs, for the quarter ended 30<sup>th</sup> June, 2020, as considered in the statement. The Statement includes financial result of a joint venture which reflects group's share of net profit / (loss) after tax of Rs.(15.77) lakhs and total comprehensive income of Rs. (15.77) lakhs for the quarter ended 30<sup>th</sup> June 2020, as considered in the consolidated unaudited financial results, in respect one joint venture, based on their interim financial information have not been audited by us. These interim financial statements / results have been audited by other auditors whose review reports have been furnished to us by the management, and our conclusion in so far it relates to the amount and disclosures in respect of subsidiary and joint venture, is based on solely on such review reports of such other auditors and the procedures performed by us as stated in paragraph 4 above.

Our opinion on the consolidated financial results is not modified in respect of this matter.

7. Based on our review conducted and procedures performed as stated in paragraph 4 above and based on consideration of the review reports of other auditors referred to in paragraph 6 above, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the afore said Indian Accounting Standard and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the Listing Regulations, including the manner in which it is to be disclosed, or that it contains any material misstatement.
