Sir/ Madam,

The Regional Controller of Mines Approve the Modification of Mining Plan including Progressive Mine Closure Plan of Belkundi Iron & Mn. Mine, Bhadrasahi Iron & Mn. Mine and Bagiaburu Iron Mine over the area of 1276.79 ha, 998.70 ha and 21.52 ha respectively of The Orissa Minerals Development Company Limited in keonjhar district of Odisha State submitted Under Rule 17(3) of Mineral Concession Rules, 2016. This approval is subject to the following conditions:

- I. The Modification of Mining Plan is approved without prejudice to any other law applicable to the mine area from time to time whether made by the Central Government, State Government or direction from any court of competent jurisdiction.
- II. The proposals shown on the plates and/or given in the document is based on the lease map/sketch submitted by the applicant/lessee and is applicable from the date of approval.
- III. It is clarified that the approval of aforesaid Modification of Mining Plan does not in any way imply the approval of the Government in terms of any other provision of Mines & Minerals (Development & Regulation) Act, 1957, or the Mineral Concession Rules, 2016 and any other laws including Forest (Conservation) Act. 1980, Environment (Protection) Act, 1986 or the rules made there under Mines Act, 1952 and Rules & Regulation made there under.

IV. Indian Bureau of Mines has not undertaken verification of mining lease boundary on the ground and does not undertake any responsibility regarding correctness of the boundaries of the leasehold shown on the ground with reference to lease map & other plans furnished by the applicant/lessee.

V. At any stage, if it is observed that the information furnished, data incorporated in the document are incorrect or misrepresent facts, the approval of the document shall be revoked with immediate effect.

VI. If this approval conflicts with any other law or court order/Direction under any statute, it shall be revoked immediately.

VII. Validity of this document shall expire on 31.03.2021 for Belkundi Iron & Mn. Mine and for Bagiaburu Iron Mine and Bhadrasahi Iron & Mn. Mine the validity of this document shall expire on 31.03.2020.

VIII. Next Financial Assurance shall be due for submission on 31.03.2021 for Belkundi Iron & Mn. Mine and for Bagiaburu Iron Mine and Bhadrasahi Iron & Mn. Mine the next Financial Assurance shall be due for submission on 31.03.2020.

IX. For Belkundi Iron & Mn. Mine, the approval of this document is subject to the revival of the Mining Lease by the State Government and the final decision of W.P(C) No. 3392/2015, Hon'ble High Court Odisha as communicated vide Director of Mines letter No. MXIII(d)01/2019/1064/DM dated 08.02.2019.

For Bagiaburu Iron Mine the approval of this document is subject to the decision of State Government on lapsing of said mining lease as communicated vide Director of Mines letter no. MXIII(d)01/2019/1062/DM dated 08.02.2019.

For Bhadrasahi Iron & Mn Mine , the approval of this document is subject subject to the revival of the Mining Lease with reference to the fresh hearing by the State Government and the final decision of W.P(C) No. 2203/2015, Hon'ble High Court Odisha as communicated vide Director of Mines letter No. MXIII(d)01/2019/1063/DM dated 08.02.2019.
