Ltd. for Permission to Commission (PTC) for synchronization of 5.615 MW plant capacity in the 15 MW solar park at Village Bhanos Tal. Patur Dist. Akola.

M/s. Blue Jet Healthcare Ltd. has requested to issue permission to commission for their 5.615 MW Solar Plant in the 15 MW solar park of M/s. Prozeal Infra Engineering Pvt.Ltd. Ltd. at Village Bhanos Tal. Patur Dist. Akola.

## The details are as under:

## In view of above, it is proposed that

The permission only for commissioning of the new solar power plant in respect of M/s. Blue Jet Healthcare Ltd. (5.615 MW), in the 15 MW solar park of M/s. Prozeal Infra Engineering Pvt.Ltd. Ltd. situated at at Village Bhanos Tal. Patur Dist. Akola may be granted subject to following terms & conditions:

- a) The permission for commissioning of the said solar PV project shall be valid for 30 days from the date of this letter.
- b) This is specifically informed that MSEDCL will not buy this power.
- c) The permission to commission is granted subject to the condition that all the statutory clearances are obtained by the generator and are in place and all the relevant Regulations

including MERC RE FORECASTING and SCHEDULING Regulations are complied with. It is mandatory to provide visibility of real time generation data to SLDC through RTU-DC & V-SAT as per undertaking provided.

- d) The permission to commission is granted only for synchronization of the project. This permission to commission shall not by itself entitle the solar generator to interchange any power with grid unless it has valid contract with any private entity within Maharashtra via Open Access permission granted by MSEDCL as per MERC (DOA) Regulations, 2016 as amended from time to time. The solar generator will be disconnected in case the solar generator has no valid open access permission granted by MSEDCL as per MERC (DOA) Regulations, 2016 as amended from time to time.
- e) Further, the infirm power injected into the grid during the period from the date of synchronization up to the date of commencement of open access shall be treated as lapsed . as per the Regulation 5 of MERC (Distribution Open Access) Regulations, 2016 as amended from time to time.
- f) In case of emergency / to ensure grid security, the instructions issued by the State Load Dispatch Center from time to time shall be binding on the solar generator and the plant shall back down or shut down the generation if system conditions so warrant. The solar generator shall not be entitled for any compensation whatsoever in such case.
- g) After commissioning of project, the certificate of commissioning shall be issued by SE O&M of concerned circle office who will be the Nodal Officer.
- h) Nodal Officer i.e., Superintending Engineer of concerned O & M Circle, MSEDCL shall disconnect the plant if the solar generator has no valid open access permission and compliance report for disconnection of solar plantshall be submitted to renewable energy section invariably by concerned SE, O & M Circle.
- i) It will be the sole responsibility of Nodal Officer to ensure monitoring and adherence of all the stipulated terms & conditions by the solar generator as mentioned above and will be personally held responsible for deviation if any.
- j) Notwithstanding, any reference on any other documents, the operations of your unit will be abided by the State Grid Code 2020, MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulation 2018 and Procedure for Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation and amendment thereof and any other related Regulations issued by CERC/MERC time to time.
