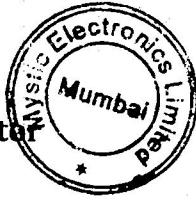

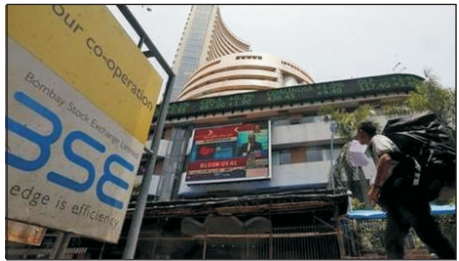
Google to alert your contacts if you're on vacation

New Delhi: Google is rolling out a new feature this month for its G Suite users where it will show a notification to your contacts in Gmail and Hangouts chats that you are away on vacation.

Available for only G Suite (Google's enterprise customers) at the moment and not the ordinary Gmail users, the feature will be fully rolled out globally from September 16, Google said in a statement. "When you have an Out of office (OOO) entry on your calendar, a notice of that OOO status will appear in Gmail and Hangouts Chat when people try to contact you," said the company.

"In Gmail, we'll show a banner about the recipient being out of office and when they'll be back in the email compose window," Google added. In Hangouts Chat, you'll also see a small notification in the chat compose window alerting you that the person you're trying to message is out of office. These notices will automatically start showing up when anyone whose calendar you have access to has an out of office event scheduled. If you'd like to disable sharing of availability information to other G Suite apps, you can do so in Calendar under Calendar settings -- Access permissions. Just deselect "Show calendar info in other Google apps, limited by access permissions." This feature will be on by default and can be disabled in the Calendar settings if you do not require this

Markets closed today on account of Ganesh Chaturthi



New Delhi: All major markets including BSE, National Stock Exchange, forex, money, bullion, oilseeds and other commodity markets except sugar will remain closed Wednesday on account of Ganesh Chaturthi. In the previous session on Friday, the BSE Sensex rose 263.86 points or 0.71 percent to 37,332.79 while the NSE Nifty edged higher by 74.95 points or 0.68 percent to 11,023.25.

Foreign portfolio investors sold shares worth a net of Rs 986.58 crore on Thursday, while domestic institutional investors purchased shares worth Rs 489.23 crore, provisional data showed. MSCI's broadest index of Asia-Pacific shares outside Japan dropped 0.3%, led by 0.5% drop in Hong Kong's Hang Seng after another weekend of violent anti-government protests. Japan's Nikkei shed 0.28%. The E-mini futures for U.S. S&P500 fell as much as 1.06% in early trade and last stood down 0.39%. The CSI300 index rose 0.3% despite the trade row escalation, a Reuters report said.

Huawei's future in India to be decided by PM Modi and Xi Jinping's meeting

New Delhi, Jayaprakash Ranjan. Huawei, a Chinese company that makes highly sophisticated equipment for telecom companies, is seen as the biggest competitor of American companies in this field today. India's market has become very important for this company, which has been banning from many western countries including America. But the problem of the company is that India is also delaying the decision in this regard. In such a situation, all the future plans of the company are now dependent on what is the decision regarding Huawei in a meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping in October.

Company officials believe that the meeting of the top leaders of the two countries will in a way determine the future of the company's business in India. According to top officials of Huawei's headquarters in Shenzhen, famous as the electronic city of China, the Indian government One has to understand that today America is targeting Chinese companies to save their company. But their next target will be Indian companies as they too are making rapid progress in technology. If we see our record in India, it is clear that how much attention we give to building a local structure there. After China, Huawei has the second largest research and research (R&D) center in Bangalore (India), which has 2,000 employees. The company has already established a mobile handset factory in Chennai. If it is allowed to land in 5G, then we can set up the second largest plant outside China for manufacturing telecom equipment in India.

Huawei has a special plan to fulfill the telecommunications utility of the pace at which the Indian economy is growing. But the company is currently waiting for the government's decision. The road ahead looks forward to the meeting of Modi and Chinfing. Asked what the future plans of the company would be if India did not allow Huawei, the official's reply was that we would probably focus in the 4G market again. But due to Reliance Jio, the condition of other telecom companies of the country has deteriorated significantly.
