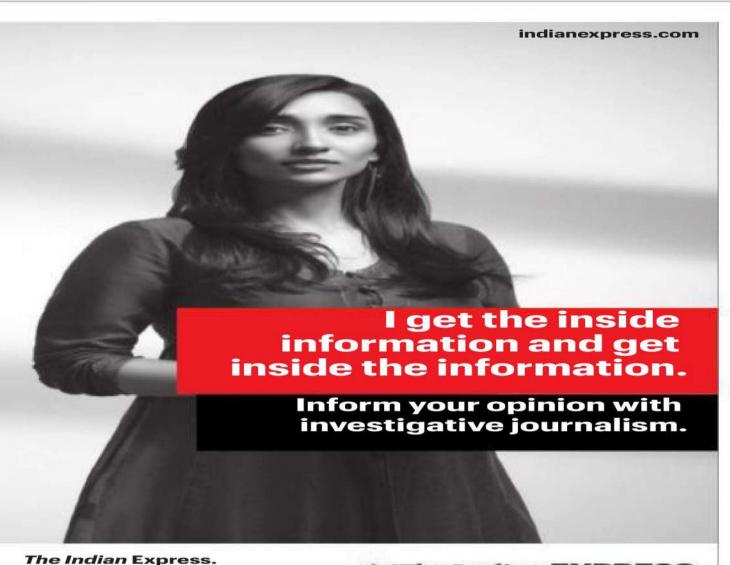

रेल मंत्री पीयूष गोयल ने बुधवार को लोकसभा में कहा कि गत एक मई से 4,621 श्रमिक स्पेशल रेलगाड़ियों को चलाने के लिए राज्य सरकारों और उनके प्रतिनिधियों से 433 करोड़ रुपए किराए के तौर पर मिले। उन्होंने सदन में एक सवाल के लिखित जवाब में कहा कि एक मई से 31 अगस्त के बीच देश में 4,621 श्रमिक स्पेशल रेलगाड़ियां चलाई गईं जिनमें 63.19 लाख लोगों ने यात्रा की।

गोयल ने कहा कि रेलवे ने श्रमिक स्पेशल रेलगाडियों के लिए यात्रियों से सीधे कोई किराया नहीं लिया, बल्कि राज्य सरकारों और उनके प्रतिनिधियों ने इसका भुगतान किया। उनके मुताबिक, राज्य सरकारों और उनके प्रतिनिधियों से किराए के तौर पर 433 करोड़ रुपए मिले।
