Pursuant to Regulation 30 and 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that the meeting of Board of Directors of the Company was held on **Friday**, 18<sup>th</sup> **August**, 2023 commenced at 3:00 P.M. through Video Conferencing and concluded at 7:00 P.M for which the outcome has already been filed by the Company on 18<sup>th</sup> August, 2023.

However, the number of equity shares allotted to Mr. Vimal Kumar Sharma got inadvertently mentioned as 250000 instead of 416666 and the details of one of the allottees, Ms. Sonal Bhaseen got inadvertently missed to be entered into the List of Allottees annexed with the Outcome of Board meeting held on 18<sup>th</sup> August, 2023 from whom the funds were duly received by the Company.
