Centre forms task force after monkeypox death

Nigerian man second case in Delhi; 20-yr-old in Rajasthan shows symptoms

SHINE JACOB Chennai, 1 August

he National Institute of Virology (NIV) in Pune on Monday confirmed the death of a 22-year-old man from Punnayur in Thrissur district of Kerala as the first case of monkeypox fatality in the country.

This comes a day after State Health Minister Veena George indicated that the man had tested positive in the United Arab Emirates (UAE). The youth, who landed at Calicut International Airport (also known as Karipur Airport) from the UAE on July 22, died on July 30 at a private hospital near Chavakkad in Thrissur.

So far, Kerala has reported four monkeypox cases.

A 35-year-old Nigerian man, living in Delhi and having no recent history of foreign travel, has tested positive for monkeypox, official sources said on Monday. He is the second person in Delhi to test positive for the infection. He has no recent history of foreign or local travel, sources told PTI.

African swine fever reported in Kerala

Barely a week after over 300 pigs were culled in Wayanad district of Kerala to prevent spread of African swine fever detected there, new cases have been reported in the state.

Wayanad and Kannur each reported one case said the respective district officials said. The latest incident of African swine fever in Wayanad has been reported in Nenmeni village of the district on Monday. The new case has made the Animal Husbandry department sound an alert in the district. The Deputy Director of Animal Husbandry in Wayanad, Dr Rajesh, told PTI that 193 pigs in and around the Nenmeni farm in Sultan Bathery will have to be culled this week to prevent the disease from spreading. There are over 20,000 pigs spread in 222 pig farms in Wayanad alone. Samples will be collected from these farms as part of surveillance, he said. According to the Food and Agriculture Organisation (FAO), African swine fever is a highly contagious and fatal viral disease of domestic pigs.

Based on media reports, the samples of the youth tested positive on July 19 and July 20 in the UAE, and yet he travelled to Kerala. Even after the state government came out with a standard operating procedure at airports on July 19, authorities failed to detect the case.

What is a cause for concern to authorities is that his public contact list may be even higher. The youth had even played soccer with friends before his health worsened. The family had informed authorities about the tests conducted in the UAE only after his condition deteriorated after July 27.

The Uttar Pradesh government will tap the Indian embassies in the US and European countries in its bid to double merchandise shipments to ₹3 trillion in the next 4-5 years.

The Indian embassies in the US, UK, Germany, open-sourced and open net-Australia, Israel, Singapore, etc. will promote the micro, small and medium enterprises (MSME) products, apart from traditional handicrafts and indigenous products, under the state's flagship One District One Product (ODOP) scheme.

"Indian embassies will provide the much-needed traction and visibility to our traditional products in key export destinations across the globe," UP Additional Chief Secretary (MSME and export promotion) Navneet Sehgal told Business Standard.

Bucking the pandemic headwinds, the UP merchandise exports had jumped 30 per cent from ₹1.07 trillion in 2020-21 to more than ₹1.40 trillion in 2021-22, of which the ODOP basket contributed 72 per cent. The UP MSME department had already tied up with leading e-commerce platforms viz. Flipkart and Amazon to market the state's marts and work on a commismerchandise basket and sion basis," Sehgal said,

Soon on e-com sites: Handicraft and handloom products

Jaipur, 1 August

The Rajasthan government has decided to promote the local handicrafts and handloom industry in a big way.

Various steps are being planned by the state government to give a boost to the sale of handloom, handicrafts and khadi products. Rajasthan is among the richest states in the country in terms of art and craft.

The state is known for its handicraft work like blue pottery, stone carvings, wood and sandal woodwork, carpets, metal work, leather craft and lac work, among others. Recently, Rajasthan's additional chief secretary of indussentations from Amazon, Flipkart and Walmart.

CHHATTISGARH State attempts to counter coal woes

Raipur, 1 August

Reeling from a severe coal crisis, secondary steel makers in Chhattisgarh are looking to enhance supply from the mines in the state.

The mineral-rich state contributes about 20 per cent to the country's secondary steel output.

"The annual requirement of coal for steel industries, including captive power plants in Chhattisgarh, is around 20-22 MT. But we are getting hardly 25 per cent of the demand," said Anil Nachrani, member of the steel ministry's advisory committee for secondary steel industry and president of Chhattisgarh sponge iron

manufacturers association.. Chhattisgarh Chief Minister Bhupesh Baghel has

come out in support of the industry and has written to Union Minister Pralhad Joshi to address the issue. "You will agree that it would be a very unfortunate decision for the state to not be able to supply coal to its small-scale industries," Baghel said in his letter. He said South Eastern Coalfields Limited (SECL) had decided to stop the coal supply to Chhattisgarh-based steel units and other industries (except power sector) from August. "This would have a serious impact on the economy and the industrial facilities barring power plants had to be shut down," the Chief Minister said.

Baghel urged Joshi to direct SECL officers to continue the supply of coal. SECL spokesperson did not respond to the company's version on the issue.
