- First OEM to bring BS6 compliant vehicles in mass segment, ahead of statutory timelines
 - Seven BS6 compliant models include industry best-sellers
 - Half of Maruti Suzuki petrol range is BS6 compliant
 - Aligned with Government's vision of green and sustainable mobility

New Delhi, 20 August 2019: Maruti Suzuki India Limited today announced that it has received enthusiastic response, from its customers, for the BS6 range of vehicles. The BS6 models offered by the Company currently constitute around 70% of the total petrol vehicles sold.

Continuing with its commitment to launch environment friendly vehicles, Maruti Suzuki introduced its first BS6 compliant petrol car, a Baleno in April 2019. This was followed by launch of BS6 compliant petrol variants of Alto 800, WagonR (1.2 L), Swift, Dzire and Ertiga much before the government stipulated date of implementation of the regulations. The forthcoming XL6 Multi-Purpose Vehicle (MPV) will also be BS6 compliant. All these vehicles are amongst the top selling models in the industry.
