SUMMARY OF THE PROCEEDINGS OF 29th ANNUAL GENERAL MEETING

DATE, TIME AND VENUE OF THE MEETING

The 29th Annual General Meeting of the Company was held on Friday, 22nd September 2023 at 1.00 PM through Video Conferencing.

PROCEEDINGS IN BRIEF

- Mr. Piyush Saraf, Chairman & Managing Director of the Company occupied the chair.
- Total 34 members including members from Promoter group were present in the meeting.
- As per Section 103 of the Companies Act, 103 the required quorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- The Chairman informed to the members that the Company is in compliance the requirement of applicable Act and the Rules and the Secretarial Standards made there under with respect to calling, convening and conducting the meeting.
- The Chairman welcomed the Members to the 29th AGM of the Company through Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who shall place request for the same.
- With the consent of the Members present the notice of the 29th AGM and the Auditor's Report were taken as read by the Chairman.
- The Chairman read out the details of remote e-voting and instructions for AGM. He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 29th AGM was provided to the Members of the Company from 9.00 am on 19th September 2023 and up to 5.00 pm on 21st September, 2023 and that the e-voting module was closed by NSDL thereafter.
- One member had registered as speaker for the AGM but he did not speak in the AGM. Thereafter the Chairman thereafter requested those Members who had not voted through remote e-voting till the time, to vote through the e-voting process provided at the AGM. Mrs. Kriti Daga, Practicing Company Secretary was appointed as Scrutinizer for scrutinizing the remote e-voting and e-voting at the AGM.
- The following items of business as set out in the notice convening 29th AGM were placed for members' consideration and approval.

RESOLUTION(S)

Ordinary Business:

- i. the Audited Standalone Financial Statements of the Company for the financial year ended 31st March, 2023 and the Reports of the Board of Directors and Auditors thereon;
- ii. To appoint Directors in place of Mr. Piyush Saraf (DIN: 02578675), who retires by rotation, being eligible, offers himself for re-appointment; and

Special Business:

- iii. To Borrow funds in excess of the limits provided under section 180 (1)(c) of the Companies Act, 2013.
- iv. To mortgage / create charge on the assets of the Company as a security towards borrowings
- v. To approve transactions under Section 185 of the Companies Act, 2013
- vi. Approval for investments/ Loans/ Guarantees/ Securities under section 186 of the Companies Act, 2013
