

TO THE BOARD OF DIRECTORS OF MERCURY TRADE LINKS LIMITED

Report on the audit of the Standalone Financial Results

Opinion

Management's Responsibilities for the Standalone Financial Results

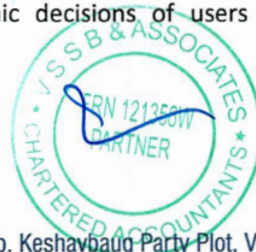

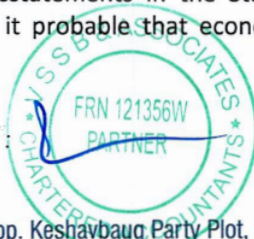


