# 27 साल में गायब की 5000 से ज्यादा कारें दिल्ली पुलिस ने दबोचा देश का सबसे बड़ा कार चोर

नई दिल्ली, (एजेंसी)। दिल्ली पुलिस ने देश के सबसे बडा कार चोर अनिल चौहान को पकडा है। अनिल के सिर करीब 5000 से ज्यादा कारें चराने का आरोप है। उसे दिल्ली की सेंट्रल डिस्ट्क्ट पुलिस के स्पेशल स्टाफ ने असम से गिरफ्तार किया है। डीसीपी श्वेता चौहान के मुताबिक, आरोपी अनिल चौहान 27 साल से अपराध की दुनिया में है और कार चोरी के अलावा उस पर हत्या, आर्म्स एक्ट और तस्करी के 180 मामलों को लेकर केस दर्ज है। हैरानी की बात ये है कि आरोपी अनिल चौहान असम सरकार में क्लास-1 कॉन्ट्रैक्टर भी है।डीसीपी श्वेता चौहान के मुताबिक आरोपी अनिल चौहान के खिलाफ केंद्रीय जांच एजेंसी एऊ ने भी शिकंजा कसा था। एऊ ने अनिल चौहान के खिलाफ РМЬА के तहत रेड कर उसकी प्रॉपर्टी भी जब्त की थी। अनिल चौहान की गिरफ्तारी के दौरान

दिल्ली पलिस के मताबिक, अनिल चौहान के पिता आर्मी में लेटफ्टिनेंट देशराज चौहान थे। अनिल ने फिलहाल असम के तेजपुर में अपना ठिकाना बनाया हुआ था। उसने 90 के दशक में कार चोरी शरू की थी, सबसे ज्यादा (मारुति 800) कारें अनिल ने ही चोरी की थी। अनिल चौहान कारें चोरी कर जम्मू-कश्मीर, नेपाल और उत्तर पूर्व के राज्यों में बेचा करता था वो भी फर्जी दस्तावेज के आधार पर। इससे पहले अनिल चौहान को दिल्ली पुलिस के अलावा उत्तर पूर्वी राज्यों की पुलिस अलग-अलग मामलों में पहले भी गिरफ्तार कर चुकी है।


# बेंगलुरु में भारी बारिश बाढ़ जैसे बने हालात
