ORDER

1. The applicant company has presented to this application under section 13(4) of the Companies Act 2013 (herein after referred to as "the Act") r/w Rule 30 of Companies (Incorporation) second amendment Rule, 2017 in form No: INC 23 vide SRN No H 87387452 dated 06.09.2019 before the Regional Director (SR), Ministry of Corporate Affairs, Chennai for confirmation of the alteration to situation clause of the Memorandum of Association of the company as approved by members by Special Resolution duly passed in accordance with Section 13(4) of the Companies Act, 2013 on 20.06.2019 which reads as under:

"RESOLVED THAT pursuant to the provisions of section 12 & 13 and other applicable provisions, if any, of the Companies Act, 2013, (including any statutory modifications or re-enactment thereof, for the time being in force) and the rules framed there under, the consent of the Members be and is hereby accorded for the alteration of the Situation Clause of the Memorandum of Association of the company by replacing Clause no. II with the below mentioned clause;

"II The registered office of the company is situated in the State of RAJASTHAN

2. The submission made in the application, including justification for shifting of the registered office from the State of Tamil Nadu to State of Rajasthan has been considered. It is observed that no objections have been received from anyone and therefore the application is allowed and alterations to the situation clause of Memorandum of Association of the applicant company are hereby approved subject to the condition that the interest of employees working at the Registered office of the Company shall not adversely be affected either by way of transfer or retrenchment or otherwise.
