The requisite quorum being present, the Chairman called the meeting to order.

The Chairman delivered his speech. The AGM notice convening the meeting was taken as read with the consent of the Members. Thereafter, the observations made by Independent Auditors and the Secretarial Auditors in their Reports were read out by the Company Secretary.

The Chairman informed the Members that the Company had provided remote e-voting facility, through the e-voting website of its Registrar & Share Transfer Agent (RTA) viz. Link Intime India Private Limited (LIPL), to its members. The members, who were present in the Meeting and had not cast their votes by remote e-voting, were provided with the facility to vote through ballot at the AGM Venue.
