

The Board of Directors of the Company at its meeting held on today appreciated the work done by Mr. Mukesh Chaudhary and also wishes him success in his future endeavors.

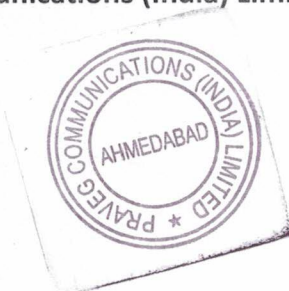
