

### Police complaints name farmers for breach in Narmada canal

Ahmedabad: In the last one week, police complaints have been filed against farmers of two villages of Viramgam taluka for causing breaches in the Narmada canal that has been supplying water for kharif crops in Ahmedabad district.

The first police complaint was filed for an incident that happened on October 8, where a group of farmers damaged the canal full of water near Kokta village. "They did because they wanted more water for their crops," said an official of Sardar Sarovar Narmada Nigam Limited (SSNNL) about the breach in the Kokta distributary canal.

The second complaint was lodged against villagers of Nadiyana village of Viramgam taluka. "This is a minor canal about six-km-long. These breaches were 4-5 metres wide," the official added.

Currently, the SSNNL officials are in the process of rebuilding the canal. ENS

#### **PRESS TRUST OF INDIA** AHMEDABAD, OCTOBER 16

A WOMAN ALLEGEDLY threw her five children into a well in Bhavnagar district, leading to the death of four of them, before she herself jumped into it in, police said Tuesday.

According to police, Gitaben Bhalia (40) left her home at Royal village in Bhavnagar on Monday evening after telling her husband that she was taking the children to a temple. On reaching Panchpipla, she threw her five children into the well and then jumped into it, an official at Aland police station said.

Some villagers raised an alarm and called the police after which the bodies were fished out from the well, he said.

Four of the children - a daughter and three sons aged between 1.5 and 7 years drowned, while the woman and her eldest daughter, aged 8, survived, the official said.

The woman appeared mentally disturbed and claimed "she saw ghosts whenever she closed her eyes", he said.

The woman has been arrested and booked under IPC sections 302 (murder) and 307 (attempt to murder), the official said.

He said during interrogation, the woman said that she was fed up with life as she was unable to look after her children due to poverty.

The IT firm owner sought the help of a consultant firm agent, Hasmukh Trivedi (62), who negotiated with the officer. Tiwari allegedly asked the owner to pay Rs 1,05,632 to open the PF accounts and an additional Rs 1,25,000 to settle the matter.

The complainant however, recorded the entire conversation with the consultant as well as the officer and then approached the ACB. ENS


