शिमला, २६ नवंबर (जनसत्ता)।

प्रदेश में कोरोना संक्रमण से आज गुरूवार 14 मरीजों की मौत हो गई जिनमें चार-चार मरीजों ने शिमला-कांगड़ा में जबिक मंडी में तीन, ऊना-सोलन-कुल्लू में 1-1 मरीज ने दम तोड़ा। प्रदेश में संक्रमण से मौत का आंकड़ा बढ़कर 589 तक पहुंच गया है। शिमला में मृतकों की संख्या 150 का आंकड़ा छू गई है। कांगड़ा में अब तक 117 मरीजों की मौत हो चुकी है जबिक मंडी में 77, कुल्लू में 63 और सोलन में 50 संक्रमितों की मौत हुई।

आज कोरोना संक्रमण से जान गंवाने वालों में 14 महिला मरीज हैं जबिक 10 पुरुष मरीज शामिल हैं। शिमला में कोविड न्यूमोनियाग्रस्त 66 साल के मरीज की मौत हो गई जबकि 53 साल के मरीज को उच्च रक्तचाप की समस्या थी और उसने भी दम तोड़ दिया। एक 88 साल के बुजुर्ग को सांस लेने में तकलीफ हो रही थी और इलाज के दौरान उसे भी नहीं बचाया जा सका। इसी तरह उच्चरक्तचाप से ग्रस्त 56 साल के एक मरीज ने भी दम तोड़ दिया। कुल्लू में मधुमेहग्रस्त 68 साल के मरीज ने दम तोड़ा है। सोलन में 64 साल की महिला की मौत हुई जबिक ऊना में 79 साल के बुजुर्ग ने संक्रमण से दम तोड़ा। बीती रात से लेकर अब तक कांगड़ा में 2 महिलाओं और दो पुरुघ मरीजों की
