Subject: Scrutinizer's Report on voting through Postal Ballot (E-voting) in terms of Section 110 of the Companies Act, 2013 read with Rule 20and Rule 22 of Companies (Management & Administration) Rules, 2014.

A. I, Vijay Kumar Mishra, Partner of M/s. VKM & Associates, Practicing Company Secretaries, have been appointed as a Scrutinizer pursuant to the resolution passed by the Board of Directors of Morarka Finance Limited (hereinafter referred to as "the Company") on 13th November, 2020 for the purpose of scrutinizing the postal ballot process conducted through remote e-voting carried out in accordance with the provisions of Section 108 and Section 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("Rules") and the other applicable provisions of the Act and the Rules made thereunder, Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the General Circulars No.14/2020 dated April 08, 2020, No.17/2020 dated April 13, 2020 and No.33/2020 dated September 28, 2020 issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars") in respect of the ordinary resolution set out in the Postal Ballot Notice dated 13th November, 2020 ("Notice").



- B. Members approval was sought on the following Special Business:
 - (a) Appointment of Ms. Priyanka G. Morarka as Non-executive Promoter Director on the board of directors the Company.
- (b) Pursuant to the provisions of the Act and MCA circulars, the Company completed dispatch of Postal Ballot Notice along with a statement setting out material facts under Section 102 of the Act as confirmed by the Company to its members in respect of the ordinary resolution through electronic mail to those members whose name appeared in the Register of Members as on Friday, 13th November, 2020 ("cut-off date") and whose email addresses are registered with the Company/RTA/Depositories. The Company also posted the notice of the Postal Ballot on its website.
- (c) The Company had availed the e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote e-voting by the Shareholders of the Company.
- (d) The shareholders of the Company holding shares as on Friday, 13th November, 2020 ("cut-off date") were entitled to vote on the proposed resolutions specified in the Notice.
- (e) The voting period for remote e-voting commenced on Friday, 20th November, 2020 (9.00 a.m.) and ended on Saturday, 19th December, 2020 at (5.00 p.m.) and the CDSL e-voting platform was blocked thereafter.



- (f) The e-voting was unblocked on 19th December, 2020 in the presence of two other people who are not in the employment of the Company and the e-voting summary statement was downloaded from e-voting website of CDSL.
- (g) All the votes cast up to 5:00 p.m. on 19th December, 2020 being the last date and time fixed by the Company for said purpose were considered for scrutiny.
- (h) The Management of the Company is responsible to ensure compliance with the requirements of the Act and rules relating to postal ballot and e-voting for the resolutions contained in the notice.
- (i) My responsibility as scrutinizer for the postal ballot process is restricted to making a Scrutinizer's Report of the votes cast in favor or against the resolution.
