National Doctors' Day :

yet a matter of immense pride and inspiration for the medical community at large. History should bear witness that when the time came and humanity needed to be saved, it was the doctors who stepped up to answer the call of duty," Vardhan was quoted as saying in a Health Ministry statement. He said that if it were not for the overzealous compassion of the medical community towards the plight of their fellow citizens, the story of how this pandemic eventually unfolded would have been drastically different and depressing. "Many doctors could have opted to stay in the comfort of their homes and see out the pandemic, but not one of you did so. On the contrary, we saw veterans and retired doctors stepping up voluntarily to help in these times of need. "We saw enthusiastic medical students, young and barely a few years into their adulthood, well aware of the risks, ready to pick up the mantle to help the nation overcome its gravest challenge in over a century," the health ministry said. Although the medical profession has been always considered a noble one and indeed many patients consider doctors as no less than god, COVID-19 has made this much more evident. Vardhan said. Invoking the Hippocratic Oath, he further said, "Wherever Art of Medicine is loved, there is also a love of humanity — said Hippocrates. It is your spirit of service, combined with your intelligence, that places you in this unique position to save the people of this country from this threat." Advising doctors to minimise risk to their lives, Vardhan enumerated a three-fold action plan for them to defeat COVID-19. "One, take care of yourself and follow proper protocols in handling patients. We do not want any of you to be infected. I personally can't bear the loss of another corona warrior... Two, we have to fight this virus as well as an infodemic. Many people visit your clinics. They trust you and follow your words. You are not only a doctor... but also a role model and guide. Tell the communities the do's and don'ts to prevent the spread of this virus. "Three, stay connected with your peers and with all of us. Be apprised of the diagnostic and treatment protocols and also contribute to it based on your knowledge and experience. What you are doing is both empowering as well as a privilege — people confide in you, trust you with their lives, look up to you." he said. The Union Health Minister also took the occasion to thank the families of doctors and acknowledged the turmoil and dilemma they must have gone through each day. "To stay away from family and friends when the world faces an existential threat is no easy task. For them to have a loved one at the forefront of this battle must have been even more daunting," Vardhan said.

Indian Military

asked about the recent drone attack on Jammu Force Station. On the situation along the Line of Control in Jammu and Kashmir, the Army chief said there has been no infiltration along the LoC after a ceasefire understanding was reached between Indian and Pakistani militaries in February. Since there is no infiltration, number of terrorists in Kashmir is lesser and

so number of terrorism-related incidents also came down, he said. "There will always be elements who will try to sabotage process of peace and development; we have to cater for that," he said without elaborating. "We have a strong counter-terrorism and counter-infiltration grid in Jammu and Kashmir and our operation to ensure peace and tranquility will continue," he said.

No Life Sentence

under section 364 A of the IPC. Ahmed, an auto driver had kidnapped a Class 6 student of St Mary's High School on the pretext of dropping him home. The child was rescued by police when the child's father went to pay the ransom. The child, who was 13 years old at the time of incident in 2011, and his father had told the lower court that Ahmed never threatened to kill or harm the boy. The top court set aside the conviction under section 364 A of the IPC. From the evidence on record regarding kidnapping, it is proved that accused had kidnapped the victim for ransom, demand of ransom was also proved. Even though offence under Section 364A has not been proved beyond reasonable doubt but the offence of kidnapping has been fully established to which effect the learned Sessions Judge has recorded a categorical finding. The offence of kidnapping having been proved, the appellant deserves to be convicted under Section 363(Punishment for kidnapping). Section 363 provides for punishment which is imprisonment of either description for a term which may extend to seven years and shall also be liable to fine, the bench said. The apex court said that it is satisfied that the appellant deserves to be sentenced with imprisonment of seven years and also liable to pay fine of Rs 5,000.

and was informed that it is now producing the Oxford/AstraZeneca vaccine, named Covishield in India, at the rate of 100 million doses a month which would soon be doubled to 200 million. They (SII) are backed by the world's most highly regarded regulator, the UK's MHRA (Medical and Healthcare products Regulatory Agency), which makes them one of the safest, best and largest vaccine manufacturers in the world. They are also about to manufacture the Novavax vaccine, which is looking like a really great vaccine, he said. India's aspiration to be the pharmacy of the world is incredibly exciting for us, he added. The minister's comments came as the National Health Service (NHS) launched plans for COVID-19 vaccines booster jabs as part of a two-stage programme alongside the annual flu vaccination programme from September. One jab in each arm will be promoted as a way of protecting against not only COVID-19 variants but also the seasonal flu. Our COVID-19 vaccination programme has been a roaring success, with almost 85 per cent of adults across the UK receiving a first dose and more than 62 per cent getting both doses, said Zahawi. We are now planning ahead to future-proof this progress and protect our most vulnerable from variants and flu ahead of the winter. Vaccines are the best way to stay on top of this virus and I urge everybody to take up the offer as soon as possible, he added. The move is aimed at prolonging the protection vaccines provide in those who are most vulnerable to serious COVID-19

ahead of the winter months.

UK Opens New

they can use a two-year period to stay on and look for a job. There are no minimum salary requirements or caps on numbers, allowing graduates on the route to work flexibly, switch jobs and develop their career as required. As we build back better, it is vital that the UK continues to be a beacon for talented young people across the globe who want to make a difference. The new Graduate route does just that, giving the best and brightest graduates the opportunity to continue contributing to the UK's prosperity and the freedom to kickstart their careers in the UK, said Patel. A coronavirus concession on the date by which students must enter the UK to qualify for the route, if they started courses in 2020 and are unable to travel due to the pandemic, was recently extended. Applicants who began their studies in autumn 2020 or in spring 2021 will need to be in the UK on a student visa by September 27 this year. Students beginning their course later this year or early next year will need to be in the UK by April 6, 2022. This has been welcomed by Indian student groups in the UK, concerned about India's categorisation under the red list of countries from where travel currently remains banned, making it compulsory for Indian students to quarantine at considerably additional expense. Many other countries do not offer that microcosm, foundation of diaspora community, natural heritage, all the cultural links, all the values that we share between our two countries. That puts us in a very strong position, both for Indian students coming here and securing their future opportunities in the workplace, Patel said. The new route, part of the post-Brexit points-based immigration system, is pegged as part of the UK's Global Britain message of attracting the best talent from around the world and covers all parts of the United Kingdom. International students are a vital part of our society, and those who graduate from our world-leading universities should have the opportunity to stay and build meaningful careers here in the UK, said Universities Minister Michelle Donelan. That is why we are introducing this new route for international graduates, enabling British businesses to attract and retain some of the brightest, most talented graduates across the globe,

and helping this nation build back better from the pandemic, she said. Anne Marie Graham, Chief Executive of UK Council for International Student Affairs, said, "We know that employability is a priority for international students coming to study in the UK." International students who are able to access this route will have the flexibility to apply for work in any sector or role that fits their skills profile, including self-employment without the need for employer sponsorship. To apply under the new Graduate route, international students must have completed an eligible course at a recognised UK higher education provider at undergraduate or higher level. Students on the route will be able to work or look for work after their studies for a maximum period of two years, or three years for Doctoral PhD students. The National Indian Students and Alumni Union UK (NISAU) was among the groups that actively lobbied the UK government for such a post-study visa route. Genuine Indian applicants with demonstrable skills should considerably benefit, it added.

Situation Along LAC

Working Mechanism for Consultation and Coordination (WMCC) on border affairs, the two sides had a "frank exchange" of views and decided to maintain dialogue to reach a mutually acceptable solution for withdrawal of troops in all friction points to enable progress in the overall ties, according to the Ministry of External Affairs (MEA). India and China were locked in a military standoff at multiple friction points in eastern Ladakh since early May last year. However, the two sides completed the withdrawal of troops and weapons from the North and South banks of Pangong lake in February following a series of military and diplomatic talks. The two sides are now engaged in talks to extend the disengagement process to the remaining friction points. India has been particularly pressing for disengagement of troops in Hot Springs, Gogra and Depsang. According to military officials, each side currently has around 50,000 to 60,000 troops along the LAC in the sensitive sector. There was no visible forward movement on disengagement of troops in the remaining friction points as the Chinese side did not show flexibility in their approach on it at the 11th round of military talks.
