Dear Sir,

This is to inform you that on August 18, 2023, we had intimated to the Stock Exchange, outcome of the Board meeting in which the Board inter-alia approved Allotment of Convertible warrants.

However, due to an inadvertent typographical error-

1. The amount of consideration received has been incorrectly mentioned in said outcome as Rs. 20,76,23,261/- (Rupees Twenty Crores Seventy Six Lakhs Twenty Three Thousand Two Hundred Sixty One only), instead of Rs 20,72,94,195.60/- (Rupees Twenty Crores Seventy Two Lakh Ninety Four Thousand One Hundred Ninety Five and Sixty Paise only).

2. Balance consideration has been incorrectly mentioned in said outcome as Rs 61,73,76,711 (Rupees Sixty One Crores Seventy Three Lakhs Seventy Six Thousand Seven Hundred Eleven Only) instead of Rs 61,77,05,776.40/- (Rupees Sixty One Crores Seventy Seven Lakhs Five Thousand Seven Hundred Seventy Six and Forty Paise Only).

All other details given in the outcome shall remain unchanged.
