Re: Reclassification under Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR") from promoter category to public category of Ajmera Realty & Infra India Limited (the "ARIIL")

A. Background:

We ,Fahrenheit Fun and Games Private Limited ,(hereinafter referred to as "the Fahrenheit" are a shareholder of the Company holding 24,99,999 (Twenty Four Lakhs Ninety Nine Thousand Nine Hundred and Nine only) equity shares constituting 7.05% of the total equity share capital, of the Company.

While filing disclosures with the stock exchanges, we have been classified under the category of "Promoter and Promoter Group" of the Company since long. This is primarily because of the reason that we were:

- (a) Controlled by the same Board of Directors for day to day operations as that of the ARIIL, and
- (b) was influenced by the ARIIL's Board of Directors in management and decision making affairs.

B.Present Status

The Board of Directors of the Fahrenheit have changed from 15th June,2019. Prior to 15th June,2019,the Board of Directors were Mr.Bandish Ajmera, Mr.Manoj Ajmera, Mr.Nimish Ajmera, Mr.Atul Ajmera and Mr Dhaval Ajmera. The ARIIL and Fahrenheit had one Director in common i.e Mr.Manoj Ajmera and rest are Director's relatives in Fahrenheit. By virtue of common Board of Directors and control in Management of Fahrenheit, we fell in the category of Promoter and Promoters Group.

However, with effect from 15th June, 2019 the entire Board of Directors of Fahrenhiet have changed ,thereby changing the manner of operations and decisions making capacity. The new board of Fahrenhiet comprises of Mr. Harsh Mehta and Mr.Raju Mamdar ,who are neither shareholders nor Board of Directors of the ARIIL.

Mr.Bandish Ajmera, Mr.Manoj Ajmera, Mr.Nimish Ajmera, Mr.Atul Ajmera and Mr Dhaval Ajmera are no longer associated with the Fahrenhiet in any manner.

The Fahrenheit was classified as "Promoter and Promoter Group" only because the Board of Directors of the ARIIL and Fahrenhiet were common. Since there is no common control over operations and affairs

of the ARIIL and Fahrenheit now, we have no association with the ARIIL except just being the small shareholder in ARIIL.

C.Request for reclassification:

In view of the aforesaid explanation and de-association with the ARIIL, I request you to reclassify my status from "Promoter and Promoter Group" to "Public"

In this regard,I undertake as follows:

- a) We, the Fahrenheit do no hold more than 10% of total voting rights in the ARIIL;
- b) We do no exercise control over the affairs of the ARIIL whether directly or indirectly;
- c) We do not have any special rights with respect to ARIIL through formal or informal arrangements including through any shareholder agreements;
- d) We do not represent on the Board of Directors of the ARIIL on our own or on my behalf or through a nominee director;
- e)We are not acting as Key as Key Managerial Person in ARIIL.;
- f) We are not a "wilful defaulter" as per the Reserve Bank of India guidelines; and
- g)We are not a fugitive economic offender.

We , also undertake to abide by the conditions listed in Regulation 31A(4) of (SEBI LODR) post such reclassification being approved by the members of the ARIIL , BSE Limited and National Stock Exchange of India Limited.

We request you to consider our request for reclassification from "Promoter & Promoter Group" category to "Public" category and accord your approval thereof at the earliest.
