

ED files money laundering case against GVK group, MIAL

New Delhi: The Enforcement Directorate (ED) has registered a money laundering case against the GVK group, the Mumbai International Airport Limited (MIAL) and others to probe violations under the Prevention of Money Laundering Act (PMLA) to the tune of Rs705 crore in the Mumbai airport operations. The ED has filed an Enforcement Case Information Report (FIR in police parlance) under the PMLA after taking cognizance of a recent CBI FIR that booked these entities in terms of criminal conspiracy and graft. The agency will

probe if genuine funds were laundered to amass personal assets by illegal routing of funds or proceeds of crime, sources said. The CBI case in this connection relates to the alleged siphoning off Rs 705 crore from the funds of the Mumbai International Airport Limited (MIAL), a joint venture under public-private partnership (PPP) between the GVK Airport Holdings Limited and the Airports Authority of India (AAI) besides other investors, by showing inflated expenditure, under-reporting of revenues, fudging of records among others.

PM SVANidhi Mobile App for street vendors: Govt launches new App to push microcredit facility to doorsteps

New Delhi: The government launched the PM SVANidhi mobile App to bring the microcredit facility under the PM SVANidhi scheme to the doorsteps of street vendors. In an effort to bring the microcredit facility under the PM SVANidhi scheme to the doorsteps of street vendors, the government today launched PM SVANidhi Mobile App. This app is aimed to provide a user-friendly digital interface for lending institutions for sourcing and processing loan applications of street vendors under the scheme, said a statement by the Ministry of Housing & Urban Affairs.

More than 1.54 lakh street vendors have applied for a working capital loan so far, out of which, over 48,000 applications have been approved and the amount has been sanctioned, the statement said. It is believed that the launch of the Mobile App will give impetus to the implementation strategy of the scheme besides promoting paper-less digital access of micro-credit facilities by the street vendors, the government said. The government launched the web portal in the last week of June. It is also noted that

the new-launched App has all the features similar to the web portal of PM SVANidhi. The web portal and the App include features such as vendor search in the survey data, e-KYC of applicants, processing of applications, and real-time monitoring. Meanwhile, the PM SVANidhi scheme was launched by Finance Minister Nirmala Sitharaman under the ambit of the Atma Nirbhar Bharat package. It was for the first time that the government brought schemes or relief measures for the street vendors of the country. The scheme facilitated street vendors to take a loan of Rs 10,000 to re-establish their businesses hit by the coronavirus-led nationwide lockdown.

The government had underlined that an interest subsidy of 7 per cent will be credited back to the beneficiaries who repay timely. Also, the vendors can avail the facility of the increased credit limit on timely repayment. The street vendors mostly operate on a small financial cushion, thus even the micro-credit support from the government is expected to give a major relief to such vendors.

PBO flags high borrowing, 'unusual' losses at Crown corporations in report

Parliament's budget watchdog says parliamentarians should probe details about steep losses at Crown corporations and increased borrowing the Liberals outlined in their recent fiscal snapshot. The fiscal and economic report said that detailed the Liberals' financial expectations, including a \$343.2-billion deficit due to COVID-19. Parliamentary budget officer Yves Giroux says in a report that there are other numbers behind the biggest ones that MPs and senators should question. He points to projections that enterprise Crown corporations, such as the Canada Mortgage and Housing Corp.

Strategic Roads to complete soon: Rajnath Singh

New Delhi: Lt. Gen. Harpal Singh briefing Defence Minister Rajnath Singh in New Delhi. Defence Minister Rajnath Singh on Tuesday directed the Border Roads Organisation (BRO) that work on the strategic Darbuk-Shyok-Daulat Beg Oldi (DSDBO) road be completed by October, a defence source said. This was conveyed at a meeting to review the progress of the construction activities in the border areas with BRO Director-General Lieutenant General Harpal Singh.

On the 255-km Darbuk-Shyok-Daulat Beg Oldi (DSDBO) road, the ongoing construction is almost done. About 45 km of black topping work is pending. Mr. Singh conveyed that this has to be completed by October, the source said. Stating that an alternative route is also being made here, the source said there was full focus on connectivity, terming it a top priority. China has been objecting to Indian road and infrastructure development at several points along the Line of Actual Control (LAC). A road branching from the DSDBO road towards the Galwan Nalah is believed to be one of the reasons for their objections. In May, as the stand-off was under way, the BRO began efforts to fully resume construction work on all roads delayed due to the pandemic. It is also building the 61 strategic Indo-China Border

Roads (ICBRs), measuring 3,323.57 km, under the direction of the China Study Group (CSG). In March, the Parliamentary Standing Committee on Defence was informed that the BRO has completed 75% of the construction work on the 61 Indo-China Border Roads (ICBRs). Of these, 12 roads measuring about 1,064 km, are in the Union Territories of Jammu and Kashmir and Ladakh, while three roads measuring about 62 km are in Sikkim.

Govt moves Supreme Court challenging Airtel's Rs 923 crore tax refund claim

New Delhi: The government has moved the Supreme Court challenging the order by the Delhi High Court allowing Bharti Airtel to claim Rs 923 crore in goods and services tax (GST) refunds. In May, Delhi High Court had allowed Sunil Mittal led telecom firm to seek refunds by correcting their tax returns filed for July-September 2017. The telco had claimed that it paid extra since it missed filing a few invoices which resulted in extra calculation of payable taxes. Delhi High Court had allowed Bharti Airtel to make corrections to

the GSTR-3B forms for the given period. Certain transactions like stock transfer from one place of business.

Cabinet nod for extension of PMGKY for 5 months till November

New Delhi: The Union Cabinet has extended the period of EPF support for businesses and workers for three more months, stated Minister Prakash Javadekar. Cabinet approves extension of EPF contribution of 24 per cent (12 per cent employees share and 12 per cent employers share) for another 3 months from June to August 2020 under Pradhan Mantri Garib Kalyan Yojana/Atma Nirbhar Bharat, said the minister. Javadekar said that the es-

timated cost of this would be Rs 4,860 crore and it will benefit 72 lakh employees. Under this scheme the Centre would pay the EPF contribution of employer and employee for establishments that have up to 100 employees. Out of that 90 per cent must be earning under Rs 15,000 monthly wage. This scheme would incentivise around 4 lakh establishments. The minister said that the Cabinet has also approved the extension for

availing benefits of the Pradhan Mantri Garib Kalyan Yojana for Ujjwala beneficiaries by three months with effect from July 1. Pradhan Mantri Garib Kalyan Yojana (PMGKY) aims to provide a safety net to the poor and vulnerable who have been hit the hardest by the pandemic. The time limit has been extended till September for availing the benefits of the scheme. This move will cost Rs 13,500 crores, said Javadekar.
