
As already informed vide our letter dated March 19, 2019, the Record Date for the said Interim Dividend is Monday, April 08, 2019.

### **COLGATE announces Second Interim Dividend of Rs. 7 per share for 2018-19**

**Mumbai, March 29, 2019:**

#### **Dividend**

At the meeting held today, the Board declared a Second Interim Dividend for the Financial Year 2018-19 of Rs. 7 per share of Re 1 each (face value) on the share capital. The dividend payout to the shareholders will be Rs. 229.5 Crore (inclusive of the dividend distribution tax of Rs. 39.1 Crore) and will be paid on April 22, 2019 to those shareholders whose names are on the Register of Members of the Company as on April 8, 2019.

Including the First Interim Dividend of Rs. 8 per share declared in October 2018, the Company has declared a total interim dividend of Rs. 15 per share for the eleven months up to February 28, 2019.
