केंद्रीय मंत्री संजीव बालयान 2013 में हुए मुजफ्फरनगर दंगों के दौरान सांप्रदायिक तनाव भड़काने और निषेधाज्ञा का उल्लंघन करने के एक मामले में गुरुवार को स्थानीय अदालत में पेश हुए। विशेष अदालत के न्यायाधीश राम सुध सिंह ने मामले में आरोपियों की पेशी की तारीख तीन अप्रैल की। इस मामले में उत्तर प्रदेश के मंत्री सुरेश राणा ने मृत कुछ भाजपा नेताओं के नाम आरोपियों के रूप

में शामिल हैं।

पूर्व सांसद भारतेंदु सिंह और विहिप की साध्वी प्राची अदालत में पेश नहीं हुई। न्यायाधीश ने उनके वकीलों को तीन अप्रैल को उनकी पेशी का निर्देश दिया। सरकारी वकील सुभाष सैनी ने बताया कि आरोपियों के खिलाफ भारतीय दंड संहिता की विभिन्न धाराओं के तहत मामला दर्ज किया गया है। आरोप है कि इन लोगों ने 30 अगस्त 2013 को नगला मंडोर गांव में पंचायत की बैठक में हिस्सा लिया था और वहां निषेधाज्ञा का उल्लंघन किया।

सांसदों व अधिकारियों से संवाद में नियमों का उल्लंघन वाले अधिकारियों के खिलाफ कड़ी कार्रवाई हो सकती है। सरकारी आदेश के अनुसार केंद्र व राज्य सरकारों के सभी अधिकारियों को सांसदों और विधायकों के साथ संवाद के मामले में नियमों का पालन करने और ऐसा नहीं होने पर कार्रवाई का सामना करने को कहा गया है।

आदेश के मुताबिक सभी राज्यों-केंद्रशासित प्रदेशों के मुख्य सचिवों से कहा गया कि सामान्य तौर पर सांसदों की आवाजाही और विशेष रूप से संसद

सत्र के दौरान अधिकारियों से जिम्मेदारियां निभाते समय संवेदनशीलता बरतने के लिए कहा जाए। सरकार के संज्ञान में मौजूदा दिशानिर्देशों में निर्दिष्ट प्रोटोकॉल नियमों के उल्लंघन के मामले सामने आने के बाद यह कार्रवाई की गई है। कार्मिक मंत्रालय ने आदेश में कहा कि जनता के मान्यता प्राप्त प्रतिनिधि के नाते हमारी लोकतांत्रिक व्यवस्था में संसद सदस्यों और विधायकों का बहुत महत्वपूर्ण स्थान होता है। इसमें कहा गया कि अपने कर्तव्यों के सिलसिले में उन्हें अक्सर भारत सरकार या राज्य सरकारों के मंत्रालयों अथवा विभागों से जानकारी लेना या सुझाव देना अथवा अधिकारियों के निर्देशों के लिए कहना आवश्यक लगता है। कार्मिक मंत्रालय, लोक शिकायत और पेंशन मंत्रालय ने प्रशासन और संसद सदस्यों व विधायिका सदस्यों के बीच आधिकारिक कामकाज से संबंधित दिशानिर्देश जारी किए हैं और उन्हें समय-समय पर दोहराया जाता है।
