Update from Divi's Labs related to COVID-19: Operations, measures put in place, support to the nation

Divi's Laboratories Limited (Divi's Labs / the company), is a globally recognized company engaged in the manufacture of life-saving Active Pharmaceutical Ingredients (APIs), and we have an important role in ensuring the availability of supplies of APIs for pharmaceuticals in India and around the world.

Update on Operations and the measures put in place

Divi's Labs, in the wake of COVID-19 pandemic and 21 days nationwide lockdown, has ensured essential staffing for business continuity while following social distancing guidelines and adopted 'Work from Home' for other staff, wherever possible, whilst ensuring compliance with the directives issued by the Central Government, State Governments and local administration.

We are currently experiencing some supply chain disruptions during this lockdown period. We are working relentlessly to minimize disruptions in our production and supply schedules. Even though the Company has put in place a business continuity plan, due to the restriction in the movement of goods and employees, we anticipate certain delays in the deliveries of our products to our customers.

We remain committed to the health and safety of our employees and their families, as well as business continuity to safeguard the interests of all stakeholders. All of the precautionary measures that are taken by the Company will remain in effect until required.

Support to the nation

When our Prime Minister Shri Narendra Modi called for a 21-day nationwide lockdown to stop the social transmission of the novel coronavirus, Divi's as a responsible corporate entity immediately stepped in to support the health officials and Government leaders as they continue to work relentlessly to mitigate the spread of the virus.



Divi's along with the support of its employees, acted very quickly and have been able to support the Government in various initiatives. Some of these activities include:

- Supported the Government by donating Rs. 5 crores for the Andhra Pradesh CM Relief Fund and Rs. 5 crores for the Telangana CM Relief Fund
- Providing daily Provisions to 28,000 people to support during the lockdown period
- Distribution of body cover suits to the personnel of Fire department, who are disinfecting the localities
- Distribution of disposable gloves, Nose masks and Sanitizers to Police, Sanitation staff and Disaster management teams as required by the district administration
- Providing Chemical and Alcohol based sanitizers to hospitals, quarantine centres and village local bodies
- Providing bleaching powder, PCB Bins and bags to 47 Gram panchayats.
- Providing food every day to patients and hospital staff at certain Quarantine centres
- Procured furniture for new Quarantine centres
- Regular distribution of sanitizers, gloves, disposable masks, Head caps, shoe covers, N95 masks, and PPE Kits to Quarantine centres.
- Procured 500 mattresses for Quarantine isolation wards
